ORDINANCE NO. 35-93

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2506 VEACH ROAD -CONTAINING 0.15 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. <u>28-93</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>July 6</u>, 19<u>93</u>, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and the sixty (60) day waiting period has been waived in accordance with KRS 81A.412 by virtue of said owners application for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the west margin of Veach Road and being 155 feet south of the south margin of 25th Street; thence continuing with the west margin of Veach Road south 48 feet to a point, said point being the northeast corner to 2510 Veach Road; thence with the south line of 2506 Veach Road west 139 feet to a point; thence north 48 feet to a point; thence with the north line of 2506 Veach Road east 139 feet to the point of beginning and containing 0.15 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements, constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400.
