AN ORDINANCE ANNEXING TO THE CITY OF
OWENSBORO, KENTUCKY, CERTAIN
UNINCORPORATED TERRITORY IN THE COUNTY
OF DAVIESS ADJOINING THE PRESENT
BOUNDARY LINE OF THE CITY, BEING THE
REAR PORTION OF 2501 ASHWOOD COURT
CONTAINING 0.277 OF AN ACRE, MORE
LESS.

WHEREAS, by Ordinance No. 52-93, heretofore passed by the
Board of Commissioners of the City of Owensboro, Kentucky, on
October 5, 1993, the City proposed to annex certain
territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official
newspaper for the city and the sixty (60) day waiting period has
been waived in accordance with KRS 81A.412 by virtue of said owners
application for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO,
KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of
Owensboro, Kentucky, and its boundary line is hereby extended so as
to include within the limits of the City of Owensboro that certain
territory in the County of Daviess, State of Kentucky, adjoining and
being adjacent to the present boundary line of the City of
Owensboro, Kentucky, more particularly described as follows:

BEGINNING at an iron pipe being the original
southwest corner to Lot No. 16, Brookhill
Subdivision and being in the present city limit
line; thence south 45 degrees 32 minutes west
51.00 feet to an iron pipe being the new
southwest corner to Lot 16; thence north 34
degrees 33 minutes west 151.65 feet to an iron
pipe; thence north 17 degrees 02 minutes west
69.90 feet to an iron pipe being the new
northwest corner to Lot 16; thence north 61
degrees 58 minutes east 49.26 feet to an iron
pipe; thence south 71 degrees 17 minutes east 34
feet to an iron pipe being the original
northwest corner to Lot No. 16; thence with the
present city limit line and with the original
west line of Lot No. 16 chords being: South 15
degrees 04 minutes east 80.64 feet to an iron
pipe found; South 8 degrees 28 minutes west
38.29 feet to an iron pipe found; South 33
degrees 09 minutes east 41.08 feet to an iron
pipe found; South 58 degrees 22 minutes east
34.55 feet to the point of beginning and
containing 0.277 acre, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400.
