## ORDINANCE NO. 20-94

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 615 SALEM DRIVE, CONTAINING 1.694 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. <u>16-94</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>May 3</u>, 19<u>94</u>, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and the sixty (60) day waiting period has been waived in accordance with KRS 81A.412 by virtue of said owners application for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at a point in the north margin of Salem Drive and being the southeast corner to 615 Salem Drive, said point also being in the present City limit line; thence with the north margin of Salem Drive N 83 degrees 20 minutes W 391.58 feet to a point; thence N 2 degrees 36 minutes E 20.00 to a point; thence N 08 degrees 06 minutes E 126.50 feet to a point in the south margin of the Wendell Ford bypass and being the northwest corner to 615 Salem Drive; thence leaving the present City limits and with the south margin of the bypass N 80 degrees 57 minutes E 47.61 feet to a point; thence N 83 degrees 15 minutes E 100.00 feet to a point; thence N 86 degrees 18 minutes E 100.00 feet to a point; thence N 89 degrees 31 minutes E 100.02 feet to a point; thence S 87 degrees 35 minutes E 49.24 feet to a point being the North east corner to 615 Salem Drive and being in the present City limits line; thence S 06 degrees 40 minutes E 216.60 to the point of beginning and containing 1.694 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400.
