ORDINANCE NO. 34-94

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2506 WEST PARRISH AVENUE, CONTAINING 0.756 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 29-94, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on June 7, 1994, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and the sixty (60) day waiting period has been waived in accordance with KRS 81A.412 by virtue of said owners application for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point being the northeast corner to 2506 West Parrish Avenue, said point also being in the south right-of-way of Parrish Avenue and being in the present city limits; thence with the present city limit line S 4 degrees 02 minutes E 393.59 feet to a point being the southeast corner to 2506 West Parrish Avenue; thence S 83 degrees 41 minutes W to a point being the southwest corner to 2506 West Parrish Avenue; thence N 4 degrees 02 minutes W 386.52 feet to a point being the northwest corner to 2506 West Parrish Avenue, said point also being in the south margin of Parrish Avenue; thence with the south margin of Parrish Avenue N 78 degrees 55 minutes E 85 feet to the point of beginning and containing 0.756 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400.
