ORDINANCE NO. 95-06

AN ORDINANCE ANNEXING CERTAIN
PROPERTY BORDERING THE SOUTHEASTERN BOUNDARY
OF THE CITY LIMITS OF THE CITY
OF PLEASUREVILLE, KENTUCKY

BE IT HEREBY ORDAINED BY THE CITY COMMISSION OF THE
CITY OF PLEASUREVILLE, KENTUCKY AS FOLLOWS:

WHEREAS, the City Commission of the City of
Pleasureville, Kentucky, having considered it to be in the
best interest of the City to facilitate the growth and
development of the community, and hereby declaring that it
is desirable to annex the unincorporated territory more
particularly described below, the Commission of the City of
Pleasureville, Kentucky does hereby ordain as follows:

The City of Pleasureville does hereby annex the
following tract of land described as follows:

Lot Demimensions measured from the center
of Highway East facing highway is 100
feet-West back of lot is 110 feet- South
Cropper side is 244 feet- North
Pleasureville side is 200 feet.

House Dimensions is 36 x 26- 936 square
feet-Living room, bedroom, kitchen and
Bath. House partial underground with
concrete poured walls and slab.


BEING part of the same property conveyed
to Herbert Fallis and Eloise Fallis by
Deed dated December 30, 1986 and
recorded in Deed Book 240, Page 570 in
the office of the Shelby County Court
Clerk.

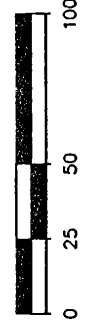

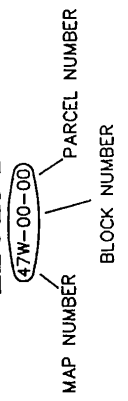
