A RESOLUTION CORRECTING AN ORIGINAL KRS 81.045 FILING AND ADOPTING A MODERN LEGAL DESCRIPTION OF TERRITORY PREVIOUSLY ANNEXED BY ORDINANCE.

Whereas, the City of Prestonsburg, Kentucky, (hereafter call the "City") in 1981 submitted a boundary statement and other information in compliance with KRS 81.045; and,

Whereas, an area annexed by Ordinance No. 08-68 November 21, 1968 was not included in the KRS 81.045 boundary statement inasmuch as the map submitted was prepared in 1968 and the City failed to make a correction to the map to include the hereinabove referenced November 21, 1968 and ordinance when the KRS 81.045 filing submitted to the Secretary of State's Office in 1981; and,

Whereas, Ordinance No. 08-68, dated November 21, 1968 was not overturned in court or in an election process; and,

Whereas, the City further wishes to provide a modern legal description and annexation plat for the purpose of showing the location of the prior November 21, 1968 annexation, same having been prepared by a professional land surveyor for the purposes stated herein; and,

Whereas, the City wishes to correct the KRS 81.045 filing and comply with the requirements of Amended KRS 81A.470, effective July 13, 2004; and,

Whereas, with respect to the Ordinance No. 08-68, dated November 21, 1968 the City does not intend to replace its prior ordinance annexing, but rather to interpret the defined boundaries of the territory previously annexed and adopt a modern legal description of territory previously annexed; and,

Whereas, the City wishes to add the modern legal description of the territory previously annexed to its KRS 81.045 filing, thereby correcting same,

NOW, THEREFORE, be it resolved by the City of Prestonsburg, Kentucky (the "City") as follows:

- 1. The City adopts the following legal description and plat attached hereto as prepared by Thomas Nairn, Licensed Professional Land Surveyor No. 3921 for the purposes stated therein, as a modern description of the property previously annexed into the corporate city limits of the City by Ordinance No. 08-68, dated November 21, 1968, a certified copy of which is attached hereto as Exhibit C, and hereby adopts said new legal description and plat as the official legal description and plat to be adopted by the City for all purposes and referencing this prior annexation.
- The new legal description as prepared by Thomas Nairn, Licensed Professional Land Surveyor No. 3921 for the purposes stated herein, is as follows:
