

ORDINANCE NO. 05-2013

AN ORDINANCE OF THE CITY OF PRESTONSBURG, KENTUCKY BY WHICH THE CITY ANNEXES INTO THE CITY CORPORATE LIMITS CERTAIN REAL PROPERTY LOCATED ALONG SOUTH LAKE DRIVE

WHEREAS, property owners within that certain tract and boundary of unincorporated territory as more specifically described herein below, and as reflected by the Annexation Map hereto attached as Exhibit "A" have given prior consent in writing and petitioned the City for annexation and incorporation into the city limits of Prestonsburg said property; and,

WHEREAS, the area is herein below more particularly described, and reflected in Exhibit "A" hereto (Proposed Annexation Map) lies adjacent to or is contiguous to the City of Prestonsburg's current boundaries; and,

WHEREAS, the Prestonsburg City Council having considered the matter and determined after due discussion and deliberation that it is in the best interest of the City and best interest of the property owners whose property is contained within the area proposed to be annexed; and,

WHEREAS, the City Council, through passage of this ordinance set forth herein below, declares it desirable to annex into the corporate limits of the City of Prestonsburg that certain are more fully described below;

NOW, THEREFORE, IT IS HEREBY RESOLVED AND IS HEREBY ORDAINED BY THE CITY OF PRESTONSBURG, KENTUCKY AS FOLLOWS;

Section I. The City of Prestonsburg does hereby annex into the municipal corporate limits the property described as follows:

BEGINNING AT A POINT ON THE EXISTING ANNEX BOUNDARY OF THE CITY OF PRESTONSBURG, SAID POINT HAVING APPROXIMATE NAD 27, KENTUCKY STATE PLANE, SOUTH ZONE COORDINATES OF NORTH 500,002.98 FEET AND EAST 2,873,581.72 FEET; THENCE WITH SAID BOUNDARY N 53°18'03" E 135.17 FEET TO A POINT ON THE RIGHT OF WAY OF KY ROUTE 3, SAID POINT BEING 180 FEET RIGHT OF STATION 20+24; THENCE WITH SAID RIGHT OF WAY S 43°57'32" E 110.37 FEET TO A POINT 100 FEET RIGHT OF STATION 21+00; THENCE S 06°16'38" W 243.24 FEET TO A POINT IN THE CENTER OF THE LEVISA FORK OF THE BIG SANDY RIVER; THENCE LEAVING SAID RIGHT OF WAY AND BIG SANDY RIVER N

BEGINNING AT A POINT ON THE EXISTING ANNEX BOUNDARY OF THE CITY OF PRESTONSBURG, SAID POINT HAVING APPROXIMATE NAD 27, KENTUCKY STATE PLANE, SOUTH ZONE COORDINATES OF NORTH 499,958.09 FEET AND EAST 2,873,521.49 FEET; THENCE WITH SAID BOUNDARY N 53°18'03" E 75.12 FEET; THENCE LEAVING SAID BOUNDARY S 33°22'24" E 287.93 FEET TO A POINT IN THE CENTER OF THE LEVISA FORK OF THE BIG SANDY RIVER; THENCE WITH SAID BIG SANDY RIVER AND ITS MEANDERS S 71°09'02" W 41.66 FEET; THENCE S 56°45'45" W 30.73 FEET; THENCE LEAVING SAID BIG SANDY RIVER N 34°11'57" W 273.08 FEET TO THE BEGINNING AND CONTAINING 0.47 ACRES OR 20,317.73 SQ. FT.

Section II. The Annexation Map attached hereto as Exhibit "A" reflects the description as hereinabove and is incorporated herein by reference as a part thereof.


Section III. Upon enactment of this ordinance the territory shall become a part of the City of Prestonsburg in accordance with KRS 81A.412.
