ORDINANCE NO. 04-2014

AN ORDINANCE ANNEXING TO THE CITY OF PRESTONSBURG, KENTUCKY CERTAIN TERRITORY OF LAND CONTIGUOUS TO THE EXISTING CITY LIMITS OF RT 23 NORTH INCLUDING ALL RIGHT OF WAYS ALONG ROADWAY ENDING AT BOUNDARY LINE OF JOHNSON COUNTY, KENTUCKY

Whereas, the City Council has determined that no part of the area to be annexed shall be included in the boundary of another city; and,

Whereas, pursuant to KRS 81A.425, notice was sent by first-class mail to affected property owner; and,

Whereas, said notice was mailed no later than fourteen (14) days prior to the meeting to which the ordinance proposing the annexation and stating the intention of the City of Prestonsburg to annex the territory received its second reading; and,

Whereas, Ordinance No. 10-2013, proposing the annexation was duly read in accordance with the Kentucky Revised Statutes, and was published and went into effect on December 27, 2013; and,

Whereas, more than sixty (60) days have elapsed since Ordinance No. 10-2013 went into effect, and no opposition was received from the property owner to the proposed annexation; and,

Whereas, all notices required by the Kentucky Revised Statutes have been provided and/or published according to law;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Prestonsburg, Kentucky that the City of Prestonsburg hereby ratifies the Mayor's signature upon and approves any and all documents necessary to effectuate the intent of this ordinance including, but not limited to the Consents to Annexation and, further, the City hereby annexes the following described unincorporated area and makes it a part of the City of Prestonsburg, Kentucky.

This Ordinance shall take effect upon its passage, approval, and publication. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason deemed separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions.
