# AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF RADCLIFF, KENTUCKY, LOCATED ON THE EAST SIDE OF SOUTH DIXIE BOULEVARD (US 31W) BETWEEN EAST LINCOLN TRAIL BOULEVARD AND TERRACE DRIVE RADCLIFF, KENTUCKY

PART OF DB 1373 PG 1327 PVA# 160-40-03-074 0.140 ACRES

WHEREAS, it is the intent of the City Council of the City of Radcliff, Kentucky, pursuant to KRS 81A.412 to annex territory which is described below, and

WHEREAS, the owners of record of the land to be annexed have given prior written consent in writing to said annexation in accordance with the requirements of KRS 81A.412, and

WHEREAS, the City is not required to enact an ordinance stating the intention of the City to annex as provided for in KRS 81A.420 when all owners of record of the land give prior consent in writing to the annexation;

NOW, THEREFORE, be it ordained by the City Council of the City of Radcliff as follows:

The following territory is hereby annexed and the same is hereby incorporated within the municipal boundaries and limits to the City of Radcliff, Kentucky, and said territory is described as follows:

A parcel of land lying and being in Hardin County, Kentucky in the Radcliff community and lying on the east side of Kentucky Highway 31W (Dixie Highway) approximately 2.8 miles north of its intersection with Kentucky 313 and being more particularly described as follows:

Unless stated otherwise, any corner monument referred to herein as a "set pin" is a set /2" x 24" rebar with a yellow plastic identification cap stamped: "G.S. Turner - P.L.S. #2153; and any corner monument referred to herein as a "found pin" is a found monument as noted on plan. All bearings stated herein are referred to Grid North as observed by GPS.

Beginning at a found rebar with no ID in the east right-of-way line of Kentucky Highway 31W (AKA Dixie Highway - R/W width varies) approximately 130' SE of Highway 144 (AKA East Vine Street), being the northwest corner of The Red Brick Cottage, Inc. (DB 905 Pg 150); being coincident with the current Radeliff Existing Corporate Boundary

Thence with the east right-of-way of US 31-W, N35°48'59" W 18.79' to an existing steel pin, said pin being the True Point of Beginning.

Thence continuing within said right-of-way, in 50°33'46" W 128.48' to a point inside the R/W;

Thence exiting the R/W and crossing Turner (DB 1373 Pg 1327) N 59°22'31" E 146.25' to a point (leaving the 31-W right-of-way at 43.62'); Thence with Turner the following two calls:

S 45°31'29" E 23.47' to a found pin;, S 54°49'10" W 106.22' to a found pin in US-31W R/W, Thence leaving Turner and following US-31W R/W S 35°43'55" E 89.32' to a found pin; Continuing with the R/W S 55°44'04" W 10.49' to the point of beginning. Having an area of 6088.39 square feet, 0.140 acres and as completed on January 17, 2025. Verified by Glenn S. Turner 1-17-25

Beginning at a found rebar with no ID in the east right-of-way line of Kentucky Highway 31W (AKA Dixie Highway — R/W width varies) approximately 130' SE of Highway 144 (AKA East Vine Street), being the northwest corner of The Red Brick Cottage, Inc. (DB 905 Pg 150); being coincident with the current Radcliff Existing Corporate Boundary

Thence with the east right-of-way of US 31-W, N35°48'59"W 18.79' to an existing steel pin, said pin being the True Point of Beginning.

Thence continuing within said right-of-way, N 50°33'46" W 128.48' to a point inside the R/W;

Thence exiting the R/W and crossing Turner (DB 1373 Pg 1327) N 59°22'31" E 146.25' to a point (leaving the 31-W right-of-way at 43.62');

Thence with Turner the following two calls;

S 45°31'29" E 23.47' to a found pin;,

S 54°49'10" W 106.22' to a found pin in US-31W R/W,


Thence leaving Turner and following US-31W R/W S 35°43'55" E 89.32' to a found pin;


