AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF RADCLIFF, KENTUCKY LOCATED ON PART OF PVA MAP NUMBER 182-10-00-012-PARENT TRACT

WHEREAS, it is the intent of the City Council of the City of Radcliff, Kentucky, pursuant to KRS 81A.412 to annex territory which is described below, and

WHEREAS, the owners of record of the land to be annexed has given prior written consent in writing to said annexation in accordance with the requirements of KRS 81A.412, and

WHEREAS, the City is not required to enact an ordinance stating the intention of the City to annex as provided for in KRS 81A.420 when all owners of record of the land give prior consent in writing to the annexation;

NOW, THEREFORE, be it Ordained by the City Council of the City of Radcliff as follows:

The following territory is hereby annexed and the same is hereby incorporated within the municipal boundaries and limits to the City of Radcliff, Kentucky, and said territory is described as follows:

Beginning at 1/2" iron pin with cap stamped Wiseman LS#3065, at the northeast corner of lot 34A Longview Subdivision, recorded in Plat Cabinet 1 sheet 4428, also being the southeast corner of lot 73A Cowley Crossing, recorded in Plat Cabinet 1 sheet 4453; thence S 81°00'00" W, 883.30 feet to a 1/2" iron pin with cap stamped Givan LS#3590, in the south property line of lot 73A Cowley Crossing, the true point of beginning, being the northeast corner of lot 35A Longview Subdivision; thence S 02°05'06" E, 185.66 feet to a 1/2" iron pin with cap stamped Givan LS#3590, in the line of Lovegildo S. Garcia, Jr. and Elisa B. Garcia Deed Book 965, Page 660, being the south east corner of lot 35A Longview Subdivision, and the south west corner of lot 34A Longview Subdivision; thence S 81°47'30" W, 481.02 feet to a 3/4" iron pipe in the line of lot 2 of Cowley Crossing Section 2 Ashbrook Estates recorded in Plat Cabinet 1 Sheet 4414, being the northwest corner of Garcia, also being the southwest corner of lot 35A Longview subdivision; thence N 01°50'31" W, 179.06 feet to a 1/2" iron pin with cap stamped Hawkins LS#2511, being the southwest corner of lot 73A Cowley Crossing, and the northeast corner of lot 1 of Cowley Crossing Section 2 Ashbrook Estates, also the northwest corner of lot 35A Longview Subdivision; thence N 81°00'00" E, 481.01 feet to the point of beginning.

Said property contains 87,125.94 square feet or 2.00 acres per a survey by Kirby A. Givan (PLS #3590) with Kirby A. Givan Land Surveying on January 6, 2007 and prepared on February 15, 2008. Said property is also known as Lot 35A as recorded on the amended plat of Longview Subdivision recorded June 8, 2007, in Plat Cabinet 1 sheet 4428 in the office of the Clerk of Hardin County Kentucky Court.

Said property is contiguous with the current City of Radcliff boundary at the being of the south west corner of lot 34A Longview Subdivision; thence S 81°47'30" W, 481.02 feet to a 3/4"

iron pipe in the line of lot 2 of Cowley Crossing Section 2 Ashbrook Estates recorded in Plat Cabinet 1 Sheet 4414, being the northwest corner of Garcia, also being the southwest corner of lot 35A Longview subdivision; thence N 01°50'31" W, 179.06 feet to a 1/2" iron pin with cap stamped Hawkins LS#2511, being the southwest corner of lot 73A Cowley Crossing, and the northeast corner of lot 1 of Cowley Crossing Section 2 Ashbrook Estates.

Title to the above described property was derived by Deed conveyed to the Daniel O. and Dawn M. Shelby, dated September 1, 2007, of record in Deed Book 1238, Page 175, in the Office of the Hardin County Court Clerk.
