On motion of the petitioners, it appearing that a petition has been filed, pursuant to KRS 81.050, to establish the City of Riverwood, that notice of the filing has been duly published, and that no defense has been interposed, and the Court being advised, it is, therefore, ORDERED AND ADJUDGED that the following described area situated in Jefferson County, Kentucky, is hereby established a city of the sixth-class known as City of Riverwood, Kentucky, namely:

" Beginning at a point in the south easterly line of Lot 105 in Riverwood Subdivision Section #3, plat of which is of record in Plat and Subdivision Book 21, Page 71 in the office of the Clerk of the County Court of Jefferson County, Kentucky, said point being 50 feet south west of Round Ridge Road; running thence north 54° 40' 40" east 1300 feet to a point; running thence north 35° 19' 20" west 1300 feet to a point; running thence south 54° 40' 40" west 1300 feet to a point; running thence south 35° 19' 20" east 1300 feet to the point of beginning. "

It is further adjudged that the following persons are appointed as trustees:

- R. E. Barnard
- W. D. Thompson
- M. L. Garlove
- R. C. Schnur
- F. G. Kaestner

In addition, the following officers are hereby appointed:

- Police Judge - W. M. Harvin
- Assessor - J. W. Ong
- Marshal - E. P. Margerum

All the said persons shall hold their respective offices until the next election, at which officers for cities and towns may be elected.

The Clerk, not later than ten (10) days from the signing of this judgment, shall certify a copy thereof to the Secretary of State of Kentucky.
