PETITION FOR INCORPORATION OF SIXTH CLASS CITY
CITY OF ROBINSWOOD, KENTUCKYJUDGMENT

At a Court held on the 25th day of June, 1965.
This action having come to be heard on Motion of the

petitioners, Leonard Abraham, Thomas B. Murnane, Jr., Dale T. McCain, Robert R. Frederick and William E. Boyd and one-hundred forty-five (145) other qualified voters residing within the boundary and territory of Jefferson County, Kentucky hereinafter described, to enter a Judgment herein establishing the City of Robinswood located in Jefferson County, Kentucky; and it appearing to the Court that the form of said proposed City does not exceed one-half mile in each direction; that at least one-hundred twenty-five (125) inhabitants reside within the boundaries of the proposed City; that the petition filed herein was signed by at least two-thirds of the qualified voters living within the boundaries of the proposed City; that notice of the filing of the petition and the intentions of this suit were duly published in two issues of The Louisville Times, a daily newspaper published in Jefferson County, Kentucky, having the largest bona fide circulation therein; and no defense or objections having been interposed to said incorporation and the Court being sufficiently advised, it is now ORDERED, ADJUDGED AND DECREED as follows:

1. That the City of Robinswood be and the same is hereby established a City of the sixth (6th) class under the Laws of the Commonwealth of Kentucky and that the boundaries of said City are as follows:

BEGINNING at an iron pipe at the Southeast corner of Lot No. 10 of Robinswood, said point being also in the North right-away line in Blankenbaker Lane as shown on the plan of Robinswood recorded in Plat and Subdivision Book #16, Page 66 of record in the Office of the Clerk of the County Court of Jefferson County, Kentucky; thence with the North line of Blankenbaker Lane South 66 degrees 57 minutes West 139.64 ft.; thence South 80 degrees 50 minutes west 111.58 ft.; thence North 76 degrees 59 minutes 30 seconds West 49.48 ft.; thence North 29 degrees 18 minutes 30 seconds west 56.62 ft.; thence North 16 degrees 31 minutes west 256.67 ft.; thence North 11 degrees 30 minutes West 91.25 ft.; thence North 07 degrees 04 minutes West 303.67 ft.; thence North 3 degrees 33 minutes 30 seconds West 99.54 ft.; thence North 1 degree 07 minutes East 359.71 ft.; thence leaving Blankenbaker Lane North 89 degrees 38 minutes East 268.96 ft.; thence South 60 degrees 19 minutes East 310.21 ft.; thence North 43 degrees 47 minutes East 394.38 ft.; thence North 32 degrees 57 minutes West 831.65 ft.; thence North 44 degrees 28 minutes East 800.03 ft.; thence South 32 degrees 26 minutes East 823.02 ft.; thence South 33 degrees 12 minutes East 911.88 ft.; thence South 57 degrees 38 minutes West 1610.75 ft.; thence South 32 degrees 49 minutes East 130.81 ft. to the point of Beginning.

2. That the following voters residing within said area are appointed as officials of the City of Robinswood to fill the office set out following the respective name:


Said persons shall hold their respective offices until the next election at which officers of cities and towns may be elected.
