JUDGMENT

The petition herein having been filed on September 8, 1972, and the petitioner having filed Exhibit E showing that notice of the filing of this suit was published in The Voice-Jeffersonian on September 21, 1972, and no objection or defense to the petition having been made or filed, and the Court being advised, it is adjudged that the following territory be and hereby is annexed to the City of St. Matthews, Kentucky, viz:

Beginning at a point in the boundary line of the City of St. Matthews, which point is the intersection of the southerly line of Westport Road with the east line of Watterson Expressway; thence with the east line of said Expressway southward to the boundary line of the City of St. Matthews and the north right-of-way line of the L. & N. Railroad; thence with the present boundary line of the City of St. Matthews as follows: north 79 degrees three minutes east 459.64 feet to a point in the north R/W of the L. & N. Railroad; thence with the north R/W of the L. & N. Railroad north 85 degrees 25 minutes east 1,150 feet, more or less, to the point of intersection of the north R/W of the L. & N. Railroad and the south line of Lake Avenue extended; thence with the south line of Lake Avenue north 49 degrees 45 minutes east to the intersection of the south line of Lake Avenue and the easterly line of Washburn Avenue; thence with the easterly line of Washburn Avenue north 39 degrees 30 minutes west to the south line of Westport Road; thence with the south line of Westport Road to the point of beginning.
