Motion having been made, and the Court being sufficiently advised, it is hereby,

Ordered and adjudged, that the territory described below be annexed to the City of St. Regis Park, Kentucky:

BEGINNING at a point in the west line of Browns Lane, a corner of the City of Louisville and S 52° 04' W 60 feet more or less from the northwest corner of the City of St. Regis Park; thence N 52° 04' E 60 feet more or less to the northwest corner of the City of St. Regis Park, a point in the east line of Browns Lane and in the south line of the City of Louisville; thence S 38° 09' E 2218 feet more or less with the line of the City of St. Regis Park to the northeast corner of the intersection of Browns Lane and Lowe Road; thence S 22° 17' E 60 feet more or less to the southeast corner of that intersection; thence S 67° 43' W to the southwest corner of that intersection; thence with the west side of Browns Lane, its several bearings and distances also being with the line of the City of Lincolnshire, unincorporated property owned by Jefferson County and the line of the City of Louisville to the place of beginning.
