ORDINANCE NO. 017-225

AN ORDINANCE ESTABLISHING THE REGULAR MEETING NIGHT AND PLACE OF MEETINGS FOR THE CITY COUNCIL OF THE CITY OF SHEPHERDSVILLE, BULLITT COUNTY, KENTUCKY.

Be it ordained by the City of Shepherdsville, Bullitt County, Kentucky, as follows:

SECTION I: The regular meeting of the City Council of the City of Shepherdsville shall be on the second and fourth Monday of each month commencing at the hour of 6:30 p.m.

SECTION II: All regularly scheduled meetings of the City Council shall be held at City Hall, 634 Conestoga Parkway, Shepherdsville, Kentucky.

SECTION III: This Ordinance shall take effect February 1, 2017.


SECTION IV: This Ordinance shall be published according to law.

SECTION V: The Clerk is directed to file with the Secretary of State, Commonwealth of Kentucky a certified copy of this Ordinance. The City Council further directs the City Clerk to file a certified copy of this Ordinance with the Bullitt County Court Clerk and Department For Local Government.

SECTION VI: Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.

SECTION VII: Ordinance No. 015-180, enacted on April 13, 2015 and relating to the regular meeting night and place of meetings for the City Council of the City of Shepherdsville, is hereby repealed in its entirety.
