ORDINANCE NO. 995-332

AN ORDINANCE ANNEXING UNINCORPORATED TERRITORY ADJOINING THE CITY OF SHEPHERDSVILLE, BULLITT COUNTY, KENTUCKY.

The City Council of the City of Shepherdsville, Bullitt County, Kentucky, does hereby ordain as follows:

SECTION I: The City Council of the City of Shepherdsville, Bullitt County, Kentucky, does hereby annex certain unincorporated territory to the City of Shepherdsville, Bullitt County, Kentucky, and such territory shall become a part of the City for all purposes under the laws of the Commonwealth of Kentucky, and such territory annexed is described as follows:

Beginning at a point in the West line of a 5 foot utility easement, which point is located North 44° West 231 feet; North 8 1/2° East 200 feet from an iron stake corner to Howlett (DB 112 P 539) in the North line of Highway 44; thence North 44° West 268.5 feet to line of Hubert Cox; thence with line of Cox North 8 3/4° East 515.5 feet to a post, corner to Tom Givhan; thence with line of Givhan, North 39 1/2° East 772 feet; thence with another line of Givhan, South 1/4° East 986 feet to a post corner to Joe Cox; thence with line of Cox, South 5 1/2° West 510 feet to a post corner to Howlett (DB 112 P 539); thence with line of Howlett North 80 3/4° West 172 feet to a post; thence North 44° West 230.7 feet to the point of beginning.

SECTION II: The City Council of the City of Shepherdsville, Bullitt County, Kentucky, does find the property described above is of an urban character which is suitable for development purposes without unreasonable delay and does hereby declare it desirable to annex into the City of Shepherdsville.

SECTION III: The Mayor of the City of Shepherdsville, Bullitt County, Kentucky, having received prior written consent of each owner of record of the land herein before described requesting annexation into the City of Shepherdsville and all provisions of KRS 81A.412 having been complied with, the herein before described property is annexed into the City of Shepherdsville, Bullitt County, Kentucky.

SECTION IV: This Ordinance shall be published according to law.

SECTION V: This Ordinance is enacted pursuant to KRS 81A.400, et.seq.

SECTION VI: Any ordinance or part of ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.

SECTION VII: Should any section, clause, line, paragraph or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not effect the remainder of the Ordinance.

Given first reading at a regular meeting of the City Council of the City of Shepherdsville, Bullitt County, Kentucky on the 9th day of January, 1995. Given second

reading, voted upon and passed at a regular meeting of the City Council of the City of Shepherdsville, Bullitt County, Kentucky on the 23 day of January, 1995.
