ORDINANCE NO. 991-241

AN ORDINANCE ANNEXING UNINCORPORATED TERRITORY ADJOINING THE CITY OF SHEPHERDSVILLE, BULLITT COUNTY, KENTUCKY.

The City Council of the City of Shepherdsville, Bullitt County, Kentucky does hereby ordain as follows:

SECTION ONE: The City Council of the City of Shepherdsville, Bullitt County, Kentucky, does hereby annex certain unincorporated territory to the City of Shepherdsville, Bullitt County, Kentucky, and such territory shall become a part of the City for all purposes under the laws of the Commonwealth of Kentucky, and such territory annexed is described as follows:

BEGINNING at a point, said point being the existing north corporation line of the City of Shepherdsville located approximately 850 feet north of McAdams Lane and in the west line of Kentucky 61, thence North 85-30-00 West, 435.60 feet to a point; thence North 82-15-00 West, 194.70 feet to a point; thence South 89-30-00 West, 234.30 to a point; thence North 82-04-11 West, 1902.64 feet to a point; thence North 10-20-00 West, 875.00 feet to a point; thence North 66-45-00 West, 1633.50 feet to a point; thence North 17-45-00 West, 49.50 feet to a point; thence North 04-15-00 East, 396.00 feet to a point; thence North 43-30-00 East, 1270.50 feet to a point; thence South 40-00-00 East, 1394.25 feet to a point; thence North 49-20-00 East, 3276.90 feet to a point; thence South 09-30-00 East, 2953.50 feet to a point; thence South 03-00-00 East, 412.50 feet to a point; thence South 19-15-00 West, 462.00 feet to a point; thence South 23-45-00 West, 363.00 feet to a point; thence South 25-15-00 West, 181.50 feet to the point of beginning and containing 256.94 acres.

SECTION TWO: The Ordinance shall be published according to law.


SECTION THREE: This Ordinance is enacted pursuant to KRS 81A.400, et.seq.

SECTION FOUR: This property having been proposed to be annexed by Ordinance No. 991-240 and all property owners and residents having requested annexation in writing and the sixty (60) day period as specified in the statute being waived by this request and no property owner or registered voter of the real property within the limits of the territory proposed to be annexed wishing to petition the Mayor requesting this issue be placed on the ballot, the City does hereby annex the above described property.


SECTION FIVE: Should any section, clause, line paragraph or part of the Ordinance be held unconstitutional or invalid for any reason, the same shall not effect the remained of the Ordinance.

Given second reading, voted upon and passed at a special meeting of the City Council of the City of Shepherdsville, Bullitt County, Kentucky, on the 12 day of August, 1991.
