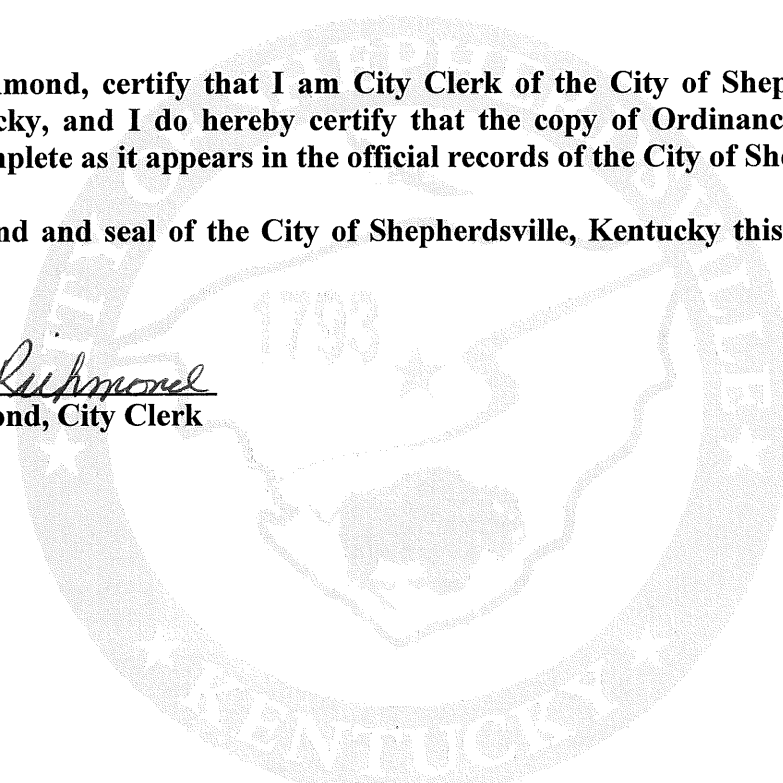

**ORDINANCE NO 015-180**

**AN ORDINANCE ESTABLISHING THE REGULAR MEETING NIGHT AND PLACE OF MEETINGS FOR THE CITY COUNCIL OF THE CITY OF SHEPHERDSVILLE, BULLITT COUNTY, KENTUCKY.**

Be it ordained by the City Council of the City of Shepherdsville, Bullitt County, Kentucky, as follows:

**SECTION I:** The regular meeting of the City Council of the City of Shepherdsville shall be on the second and fourth Tuesday of each month commencing at the hour of 6:30 p.m.

**SECTION II:** All regularly scheduled meetings of the City Council shall be held at City Hall, 634 Conestoga Parkway, Shepherdsville, Kentucky.

**SECTION III:** This Ordinance shall take effect on July 7, 2015.

**SECTION IV:** This Ordinance shall be published according to law.

**SECTION V:** The Clerk is directed to file with the Secretary of State, Commonwealth of Kentucky a certified copy of this Ordinance. The City Council further directs the City Clerk to file a certified copy of this Ordinance with the Bullitt County Court Clerk and Department For Local Government.

**SECTION VI:** Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.

**SECTION VII:** Any Ordinance or part of Ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed (006-710).
