Whereas it appears that through an inadvertant error the description of the two tracts of land which are the subject of this annexation proceeding was not truly in conformity with the understanding of the parties with regard to the area being annexed; and it now appearing that the true and correct discription of the area is available,

IT IS HEREBY ORDERED AND ADJUDGED, with the Agreement of the parties by counsel, that the description of the tracts annexed in this proceeding is amended to read as follows:

TRACT #1 BEGINNING at a point in the present West boundary line of the City of Shively, Kentucky, said point being South 03° 51' 15" West 499.67 feet from the center line of Mercer Avenue and being in the Southwest right of way line of Interstate Highway I-264 of the Commonwealth of Kentucky, said point being 130 feet left of center line Station 156+21 16, thence with said right of way line North and West to a point in the present boundary line of the City of Shively, Kentucky, said point being South 17° 56' 03" East, 165.86 feet from the center line of Garrs Lane and being 126.00 feet left of center line Station 169+04 10 of highway I-264, thence with the existing boundary lines of the City of Shively, Kentucky and crossing said interstate highway I-264, South 86° 38' 56" East and South 03° 51' 15" West, again crossing interstate highway I-264 passing center line Station 157+14 45 to the point of beginning.

TRACT #2 BEGINNING at a point in the present boundary line of the City of Shively, Kentucky, said point being North 17° 56' 03" West 26.45 feet from

the center line of Garrs Lane and being in the Southwest right of way line of Interstate Highway I-264 of the Commonwealth of Kentucky, said point being 156 feet left of center line Station 170+80⁰⁰, thence with said right of way line Northwest and Northeast to a point in the present boundary line of the City of Shively, Kentucky, said point being also in the West right of way line of Interstate Highway I-264 and the North Right of Way line of Huber Road, said point being 115.11 feet left of Center line Station 216+25³⁷, thence with said boundary line crossing Interstate Highway I-264 passing center line station 216+14⁹⁵, thence continuing with the boundary line of the City of Shively, Kentucky, Southwesterly to the point of beginning.

The Clerk of this Court shall forward a certified copy of this Judgment to the City Council of the City of Shively, Kentucky, to be entered upon the records of said Legislative body.

Any costs associated with the filing and entry of this Amended Judgment shall be borne by the Petitioner, the City of Shively, Kentucky.
