This case being taken under submission on the Petition of the City of Shively, Kentucky, a city of the fourth class, and it appearing that no remonstrance has been filed against annexation and it further appearing to the Court's satisfaction that the annexation will be for the interest of the City of Shively and that annexation will cause no material injury to the owners of real estate in the area proposed to be annexed, and the Court finding that the requirements of KRS 81.210 and 81.220 applicable to said annexation have been complied with; now, therefore, the Court being otherwise sufficiently advised it is hereby ORDERED AND ADJUDGED as follows:

1. That the proposed annexation by the City of Shively, Kentucky, of the tract of land hereinafter described be, and the same is hereby approved by the Court as an annexation to the corporate limits of the City of Shively, Kentucky, and that the boundary of the said City, may, by appropriate ordinance, be extended to include therein the following tract of land which is the subject of this annexation proceeding:

BEGINNING at a point in the boundary line of the City of Shively, Kentucky, said point being in the Southwest corner of Martin Avenue and Dover Road; thence with the said boundary line of the City of Shively South 87 degrees 18 minutes 52 seconds East 95 feet to the true point of beginning; thence leaving said City of Shively boundary North 02 degrees 41 minutes 08 seconds East 25.0 feet to a point; thence South 87 degrees 18 minutes 52 seconds East 1375.64 feet to a point in the boundary of said

City of Shively, Kentucky; thence with said City of Shively boundary South 02 degrees 41 minutes 08 seconds West 25.0 feet, North 87 degrees 18 minutes 52 seconds West 139.5 feet, South 02 degrees 41 minutes 08 seconds West, 20.0 feet, North 87 degrees 18 minutes 52 seconds West, 616.29 feet, thence North 02 degrees 41 minutes 08 seconds East 20.0 feet, thence Northwesterly 619.8 feet to the true point of beginning, containing 1.07 acres, more or less, and being a part of said land described in a deed from C. F. Martin and Dora L. Martin to Benjamin Goda, dated October 9, 1876 and recorded in Deed Book 203, page 428, in the office of the Clerk of the County Court of Jefferson County, Kentucky, said parcel of land now known as Luckert Avenue.

2. That the Clerk of this Court shall forward a certified copy of this Judgment to the City Council of the City of Shively, Kentucky, to be entered upon the records of said legislative body.

3. The costs of this action shall be paid by the City of Shively, Kentucky.
