ORDINANCE ANNEXING PROPERTY BY CONSENT

ORDINANCE ANNEXING 0.64 AC (27,844.84 SQUARE FEET) LOCATED SOUTH OF I-64 AND WEST OF KY 1848 AND CONTIGIOUS WITH THE PRESENT CITY LIMITS OF THE CITY OF SIMPSONVILLE, KENTUCKY.

BE IT HEREBY ORDAINED BY THE CITY COMMISSION OF THE CITY OF SIMPSONVILLE, KENTUCKY AS FOLLOWS:

Pursuant to KRS 81A.412, the Simpsonville City Commission finds that the hereinafter described real estate located south of the present city limits of Simpsonville, Kentucky on the west side of KY 1848, and south of I-64 interchange at KY Highway 1848 is suitable for development for urban purposes without unreasonable delay. Said property is contiguous to the present Simpsonville City limits at the time this ordinance is to be effective. The Simpsonville City Commission further finds that said property is not included within the bounds of any other incorporated city and the owners of said property are James Robert Walters, Elizabeth Walters Settle and Kitty Walters Caudill, Trustee of the Kitty Walters Caudill Revocable Trust dated January 18, 1989, as restated December 23, 1997, by deed dated May 16, 2007, of record Deed Book 500 Page 189; and by Quitclaim Deed dated August 20, 2008, of record in Deed Book 516, Page 777, all in the Shelby County Clerk's Office, and further with the property owners having executed a written consent to be annexed within the city limits of Simpsonville—see Exhibit A attached). See copy of description and map attached hereto as Exhibits B and C.

Based upon the aforementioned findings, the Simpsonville City Commission declares that it is desirable to annex this unincorporated territory described in the attached exhibits, and it hereby annexes to the City of Simpsonville and its boundary line is extended so as to include within the city limits of Simpsonville the property described on the attached Exhibits B and further outlined in the map which is attached as Exhibit C to this Ordinance.

This ordinance shall be effective upon adoption by the Simpsonville City Commission and publication in accordance with Chapter 424 of the Kentucky Revised Statutes.





**WRITTEN DESCRIPTION
FOR
ANNEXATION**

(KITTY WALTERS CAUDILL PROPERTY)

BEGINNING at a point in the centerline of Proctor Lane at its intersection with the south right-of-way line of Veechdale-Clark Station Road (a.k.a. Kentucky Highway 1399); thence leaving said south right-of-way line with said centerline **S11°22'57"E, 232.48'** to a point; thence leaving said centerline **S78°07'48"W, 165.57'** to a point along the easterly property line of the tract conveyed to AKDB, LLC by deed of record in Deed Book 386, Page 330 in the office of the Clerk of Shelby County, Kentucky, said point also being a common point with the northwest corner of the tract conveyed to Ada Green, Raymond Yocum and Benny Yocum by deed of record in Deed Book 471, Page 563 in the aforesaid Clerks office; thence with said easterly property line **N11°26'04"W, 214.85'** to a point along the aforesaid south right-of-way line of Veechdale-Clark Station Road (a.k.a. Kentucky Highway 1399); thence leaving said easterly property line **S69°44'04"E, 55.05'** to a point; thence **S49°51'19"E, 142.22'** to a point; thence **N11°06'38"W, 159.83'** to a point; thence **N79°42'05"E, 29.66'** to the point of **BEGINNING**, containing 27,844.84 square feet.

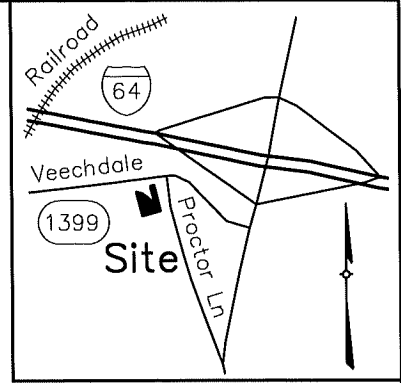

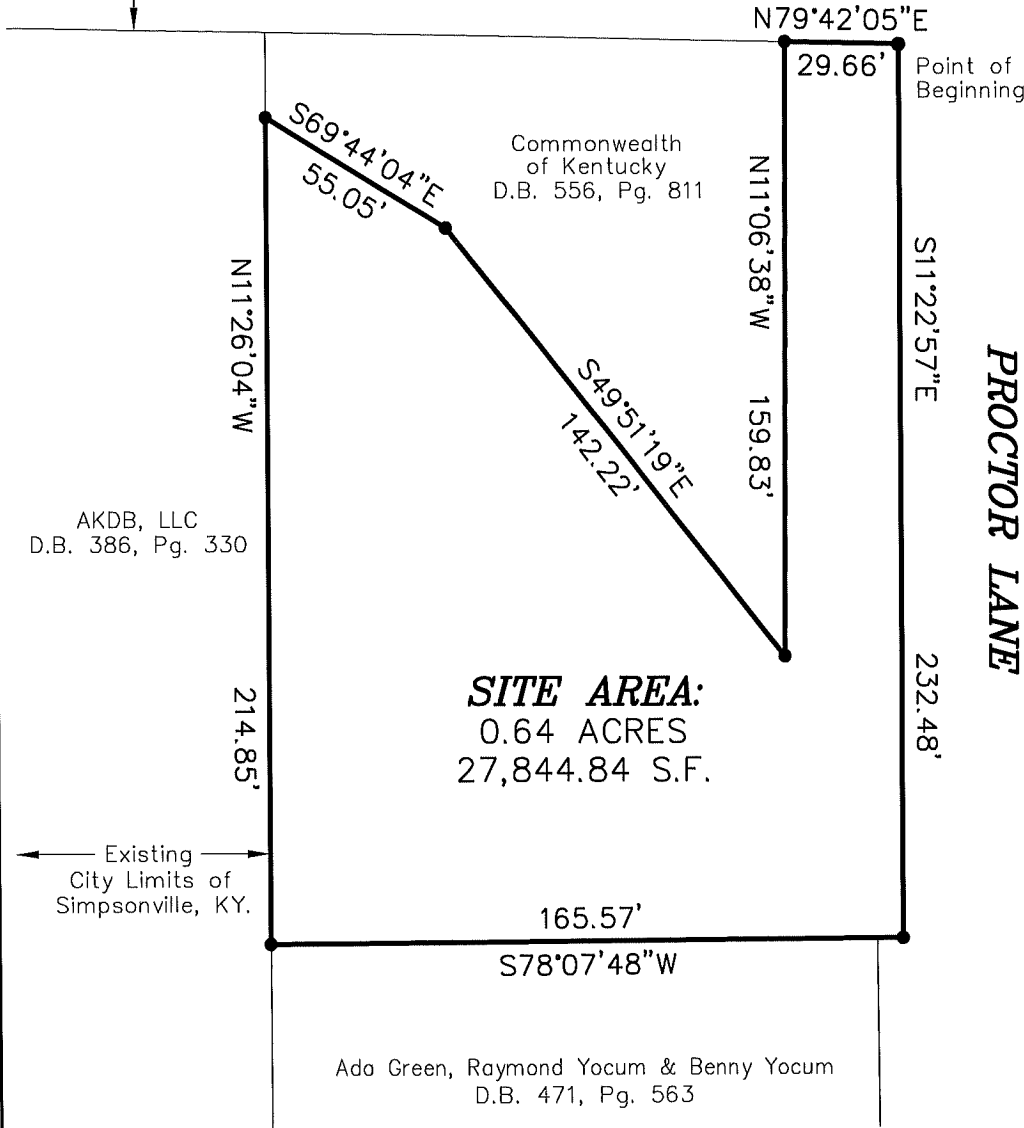

Simpsonville, KY.

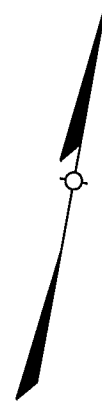
VEECHDALE-CLARK STATION ROAD

ANNEXATION PLAT

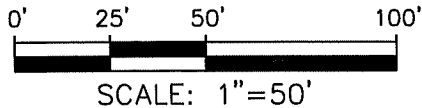
