110.2 ANNEXATION PROPOSAL

SECTION ONE: The following described property be and is hereby annexed to the City of Stanford, Kentucky and shall become effective upon the publication of the final adoption of the within ordinance.

SECTION TWO: A certain tract of land lying to the north of the present city limits, to the east of U.S. Highway 150 and the west of state road No. 590 (Hubble Road), then south of Joe T. Embry and Glen Alford property and being more fully described as follows:

Beginning on a post in the fence line of Joe T. Embry property and in the present city limits of the City of Stanford, said point being S 14 degrees 35 minutes east 558 feet from the present city limits corner marker on the east of U.S. Highway No. 150 and approximately 130 south of Embry's barn; thence with line of Embry north 80 degrees 00 minutes east 1629 feet to an ash in fence corner behind Noes residence; thence N 17 deg. 00 minutes W 662 feet to post corner of same; thence north 80 degrees 45 minutes east 883 feet corner to same; thence N 29 degrees 30 minutes W 806 feet to corner of same; thence N 71 degrees 45 minutes east 1645 feet to post corner of Embry's and Glen Alford; thence with line of Alford, S 13 degrees 45 minutes E 1279 feet to corner of same; thence N 81 degrees 00 minutes E 1615 feet to post; thence N 7 degrees 30 minutes W 100 feet to post; thence N 82 degrees 00 minutes E with fence line along north side of Moore garage, 353 feet to a point in the center line of Hubble Road, a corner to Glen Alford; thence with said Hubble Road S 18 degrees 00 minutes E 94 feet to point in intersection of Hubble Road (state highway 590) and Old US Highway No. 27; thence with centerline of Hubble Road, the following calls: S 35 degrees 30 minutes west 161 feet; S 28 degrees 30 minutes W 80 feet; S 20 degrees 30 minutes W 128 feet; S 16 degrees 30 minutes W 361 feet; S 12 degrees 00 minutes W 162 feet; S 3 degrees 00 minutes W 375 feet; S 14 degrees 00 minutes W 604 feet; S 15 degrees 00 minutes W 473 feet to sharp corner in road; thence S 54 degrees 30 minutes E 274 feet to a point in intersection of Hubble Road and US Highway No. 27; thence with center line of US Highway No. 27 S 31 degrees 45 minutes W 773 feet to a point as called for in present city limits (point being 75 feet west of US Highway No. 27 and 45 feet South of Kentucky Highway No. 590); thence with present city limits line S 28 degrees 35 minutes W 1200 feet, thence N 73 degrees 25 minutes W 1776 feet; thence S 73 degrees 05 minutes W 1947 feet to a point, said point being

110 feet north of Phillips Court,; thence north 14 dehees  
35 minutes W 2919 feet to the point of beginning, con-  
taining 412.34 acres, more or less.
