AMENDED ORDINANCE ANNEXING THE AREA APPROXIMATELY ONE-HALF MILE SOUTH OF STANFORD ALONG US 27 AND INCLUDING THE SURROUNDING PROPERTIES.

WHEREAS, the City of Stanford desires to amend Ordinance 110.11, Ordinance Annexing the Area Approximately One-Half Mile South of Stanford Along US 27 and Including the Surrounding Properties, thereby correcting it's property description, and

WHEREAS, the territory proposed to be annexed is contiguous to the City of Stanford, no part of the land is situated in another city or county, no party of the proposed annexation is within an agricultural district, and the proposed territory is suitable for development for urban purposes, without unreasonable delay, because of population density, commercial, industrial, and governmental use of land, or subdivision of land;

WHEREAS, the residents and the City will be benefited by the annexation, and said annexation is desirable;

WHEREAS, KRS 81A establishes the procedures for the annexation of contiguous territory and as such pursuant to KRS 81A.425 notice was sent via first class certified mail to each property owner of record with the Lincoln County Property Valuation Administration as of January 1, 2018. Said notice was mailed no later than fourteen days prior to the meeting at which ordinance proposing the annexation and stating the intention to annex the herein referenced property received its second reading

WHEREAS, Ordinance number 2018-1004, proposing the annexation was duly read in accordance with the Kentucky Revised Statues, was published, and went into effect on October 4th, 2018;

WHEREAS, more than sixty days have elapsed since Ordinance Number 2018-1004 went into effect and no petition containing signature of property owners in the area to be annexed has been received by the Mayor pursuant to KRS 81A.420, and

WHEREAS, all notices required by the Kentucky Revised Statutes have been provided and/or published according to law;

NOW THEREFORE BE IT ORDAINED BY THE CITY OF STANFORD AS FOLLOWS;

<u>Section 1</u>: That the City of Stanford hereby ratifies the Mayor's signature upon and approves any and all documents necessary to effectuate the intent of this Ordinance.

<u>Section 2</u>: The City of Stanford hereby annexes the following described unincorporated area and makes it a part of the City of Stanford, Kentucky:

Ready Mix, Inc. (D.B. 411, PG. 101) and being on the western edge of right-of-way of US Hwy 27;
