SUMMARY

AN ORDINANCE ANNEXING TO THE CITY OF STANTON, KENTUCKY, CERTAIN LAND IN POWELL COUNTY, KENTUCKY, LYING ADJACENT TO THE EXISTING CITY LIMITS AND SITUATED ON WALNUT LANE IN OAK RIDGE ESTATES ADJACENT TO THE POWELL COUNTY INDUSTRIAL DEVELOPMENT AUTHORITY PREMISES.

This is an ordinance annexing certain land in Powell County, Kentucky, lying adjacent to the existing City limits and situated on Walnut Lane in Oak Ridge Estates adjacent to the Powell County Industrial Development Authority Premises.

The ordinance further directs the City Clerk to publish this summary after the adoption of the ordinance and provides that the ordinance shall become effective upon publication.

ORDINANCE NO. 94-04

AN ORDINANCE ANNEXING TO THE CITY OF STANTON, KENTUCKY, CERTAIN LAND IN POWELL COUNTY, KENTUCKY LYING ADJACENT TO THE EXISTING CITY LIMITS AND SITUATED ON WALNUT LANE IN OAK RIDGE ESTATES ADJACENT TO THE POWELL COUNTY INDUSTRIAL DEVELOPMENT AUTHORITY PREMISES.

WHEREAS, the City of Stanton, Kentucky, adopted Ordinance No. 94-04 on 12-8-94, proposing to annex certain unincorporated territory located in Powell County, Kentucky, and

WHEREAS, a Summary of said Ordinance was duly published on Dec 15, 1994, according to the requirements of KRS 83A.060(9), and

WHEREAS, no petition in opposition to the proposed annexation has been received by the Mayor;

NOW, THEREFORE, BE IT ORDAINED by the City of Stanton, Kentucky, as follows:

SECTION I: That the following described unincorporated territory, located in Powell County, Kentucky, be and it is hereby annexed to the City of Stanton, Kentucky:

A certain tract or parcel of land lying and being in Powell County, Kentucky on Walnut Lane in Oak Ridge Estates, Lots No. 5, 6, 7, 8, 9, 10, and 11, and the street, Walnut Lane, more particularly described by the plat recorded in Cabinet 1, Slide 82, Revision 3, in the Powell County Clerk's Office, a copy of which is attached hereto as Exhibit "A".

SECTION II: The City Clerk is hereby authorized and directed to publish a summary of this ordinance according to the requirements of KRS 83A.060(9).

SECTION III: This ordinance shall become effective upon

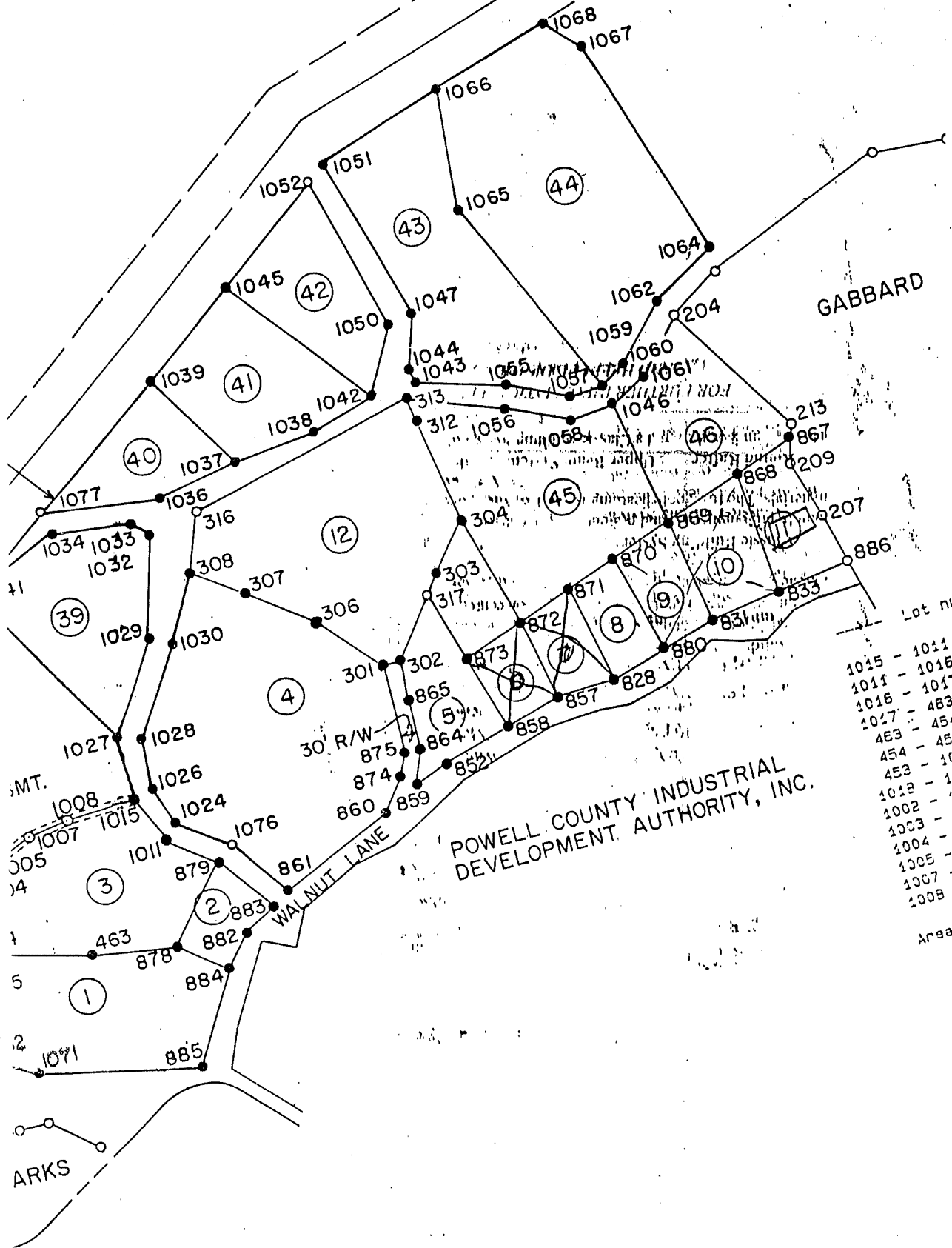
publication as required by law.
