This action having come on for a hearing on order of the Court, and it appearing to the Court that notices of same have been given in accordance with the Order of the Court, and it further appearing to the Court, and the Court being sufficiently advised on the Petition herein, that the property within the described boundaries of said city is sufficient to meet the said requirements of law which govern the creation of Sixth (6th) Class cities, and the Court being sufficiently advised,

IT IS ORDERED and ADJUDGED AS follows:

1. That a city to be known as THORNHILL, KENTUCKY, be and the same hereby is established as a municipal corporation of the Sixth (6th) Class city within the following described boundaries shown on the map filed with the petition filed herein, to-wit:

BEGINNING at an iron pipe at the Northwest corner of Lot 74, THORNHILL SUBDIVISION, SECTION NUMBER 2, recorded in plat book 24, page 9 in the Office of the Clerk of the County Court of Jefferson County, Kentucky, said point being the Southwest corner of Lot 73, of the aforesaid subdivision; thence N 56° 40' 00" E 781 feet to an iron pipe; thence S 33° 20' 00" E 781 feet to an iron pipe; thence S 56° 40' 00" W 781 feet to an iron pipe; thence N 33° 20' 00" W 781 feet to the point of beginning and containing approximately 14 Acres.





All of the Trustees and Officers above appointed, shall hold their respective offices until the next election of the officers of cities and towns may be held.


