DESCRIPTION OF THE BOUNDARY OF THE CITY OF UNION AS OF 6/1/81

Located generally in Boone County Kentucky on U. S. Highway # 42, the Mt. Zion Road and the Union-Big Bone Road and described thus; BEGINNING at the most Northerly corner of the original square mile incorporation of the City of Union on U. S. Highway # 42, which said corner is S 35 E 30 feet from the Southeast corner of the original Jones Service station building; thence in a Northeasterly direction and running with the centerline of the pavement on U. S. Highway # 42 a distance of 7200 feet or sufficient to reach its intersection with the centerline of the Gunpowder Road at Sugartit; thence in a Southeasterly direction and running with the centerline of said Gunpowder Road a distance of 8300 feet or sufficient to reach its intersection with the centerline of the Mt. Zion Road; thence in a Southwesterly direction along the centerline of said Mt. Zion Road a distance of 4150 feet or sufficient to reach the most Easterly corner of the City of Union in said road; thence leaving said road, S 3 W 355 feet, S 70-30 W 440 feet to a corner with the original House 35 acres tract; thence with the East line thereof, S 5-0 W 2070 feet; thence with lines of the Crume Subdivision, S 5-0 W 600 feet to a corner thereof, N 83-30 W 2082 feet to a corner thereof, S 5-0 W 265.6 feet to a corner thereof, N 87-30 W 1371.3 feet to a point in the Southwest line of U.S. Highway # 42; thence in a Northwesterly direction with a curve to the left or West a distance of 300 feet or sufficient to reach the most Southerly corner of the original mile square incorporation of the City of Union; thence with lines of said incorporation, N 58-5 W 5280 feet to a corner thereof, N 31-55 E 5280

feet to the place of beginning containing approximately 2.75 square miles.

The above boundary encompasses the original 1 mile square incorporation boundary, plus annexations of lands on the Mt. Zion Road and lands South of said road on the Northeast side of U. S. Highway # 42 and 1.42 square miles on the Northeast side of the original incorporation boundary running along U.S. Highway 42 to Gunpowder Road and along Gunpowder Road and Mt. Zion Road.
