ORDINANCE NO. 110.19

**ORDINANCE ANNEXING TO THE CITY OF VANCEBURG,
KENTUCKY CERTAIN TERRITORY OF LAND
CONTIGUOUS TO THE EXISTING CITY LIMITS
OF VANCEBURG, KENTUCKY**

WHEREAS, the City Council has determined that the hereinafter described ~~territory is urban in character and/or suitable for development for urban purposes~~ by reason of population density and/or commercial and industrial use of land; and

WHEREAS, the City Council has determined that no part of the area to be annexed is included in the boundary of another city; and

WHEREAS, pursuant to KRS 81A.425, notice was sent by first class mail to each property owner listed on the records of the Lewis County Property Valuation Administrator as of January 1, 2019; and

WHEREAS, said notice was mailed no later than fourteen (14) days prior to the meeting at which the Ordinance proposing the annexation and stating the intention of the City of Vanceburg to annex the territory received its second reading; and

WHEREAS, Ordinance No. 110.13, proposing the annexation was duly read in accordance with the Kentucky Revised Statutes, and was published and went into effect on February 12, 2019; and

WHEREAS, more than sixty (60) days have elapsed since Ordinance 110.13 went into effect; and

WHEREAS, all notices required by the Kentucky Revised Statutes have been provided and/or published according to law; and

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Vanceburg, Kentucky, that the City of Vanceburg hereby ratifies the Mayor's signature upon and approves any and all documents necessary to effectuate the intent of this Ordinance and, further, the City hereby annexes the following described unincorporated area and makes it a part of the City of Vanceburg, Kentucky:

This Ordinance shall take effect upon its passage, approval, and publication. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions.

PROPOSED CITY OF VANCEBURG ANNEXATION
OF Lewis County School property and adjoining property
Ordinance 110.19

Being a Parcel of land situated on the AA-Highway, in Lewis County, Kentucky. And being the Lewis County School District property (D.B. 172 PG. 548), the Lewis County Fire Department (D.B. 250 PG. 502), the City of Vanceburg (D.B. 108 PG. 630), the David O. Lykins Jr. (D.B. 251 PG. 345), Southern Manor Baptist Church (D.B. 150 PG. 572), Norcon Lewis LLC (D.B. 225 PG. 523) and a part of the Carl Ginn property (D.B. 202 PG. 602). Being more particularly described as follows:

Beginning at a Right-of-Way monument found at station 2711+40.97 and 147.33' left. Said monument is also the southwest corner of the Carl Ginn property (D.B. 202 PG. 602).

Having the Kentucky Single Zone, SPCS U.S. Feet. (FIPS: 1600) Coordinates of N: 4113257.21
