AN ORDINANCE ANNEXING TO THE CITY OF VINE GROVE, KENTUCKY, PROPERTY LOCATED ADJACENT TO THE SOUTH RIGHT OF WAY OF KENTUCKY HIGHWAY 144 ON THE NORTH TO WEST SIDE OF THE CITY

WHEREAS, the City Council of the City of Vine Grove, pursuant to KRS 81A.420, on December 6, 1990, adopted an Ordinance stating the intention of the City of Vine Grove to annex territory which is described below: and

WHEREAS, said property was accurately described in said Ordinance and further complies with all the requirements of KRS 81A.420; and

WHEREAS, more than sixty (60) days have passed since the enactment and publication of said Ordinance indicating the intention of the City of Vine Grove to annex property located adjacent to the south R/W of Kentucky Highway 144; and the Mayor has not received any petition or other remonstrance against said annexation;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VINE GROVE AS FOLLOWS:

The following property is hereby annexed and the same is hereby incorporated within the municipal boundaries and limits of the City of Vine Grove, Kentucky:

Said property or territory is described as follows:

Beginning in the South R/W of Ky. Hwy. 144 in the existing city limits, said point is a corner of Leroy Straney, thence with Straney in a southerly direction for a distance of approximately 500 feet, thence crossing Straney property in a westerly direction approximately 500 feet, thence continuing across Straney property in a southerly direction approximately 1150 feet to a corner of Straney, thence with the Straney property line and then continuing across the Straney property in a westerly direction approximately 900 feet, thence in a southerly direction crossing Straney property, Otter Creek Road and continuing with J.T. Alton property approximately 400 feet, thence crossing the Alton property for three calls; easterly for approximately 170 feet, thence southerly approximately 170 feet, thence easterly approximately 1250 feet to a point in the line of Alton,
