

ORDINANCE NO. 19, SERIES 1983

AN ORDINANCE ANNEXING TO THE CITY OF WATTERSON PARK A CERTAIN TRACT OF LAND IN THE COUNTY OF JEFFERSON, BETWEEN THE NORTH RIGHT-OF-WAY LINE OF THE SOUTHERN RAILROAD AND THE SOUTH RIGHT-OF-WAY LINE OF THE SOUTHERN RAILROAD; AND BETWEEN THE WEST RIGHT-OF-WAY LINE OF JENNINGS LANE AND THE SOUTHWEST RIGHT-OF-WAY LINE OF NEWBURG ROAD, THE SAID AREA BEING MORE PARTICULARLY HEREINAFTER DESCRIBED.

**WHEREAS**, Ordinance NO. 14, Series 1983 was duly enacted by the City of Watterson Park; and,

**WHEREAS**, Ordinance NO. 14, Series 1983 was advertised in accordance with the provisions of KRS Chapters 81A and 424; and,

**WHEREAS**, no resident voter or real property owner has petitioned the Mayor in Opposition to the annexation proposed in Ordinance NO. 14, Series 1983; and,

**WHEREAS**, The Southern Railroad Company, the only owner of real property in the area proposed for annexation by Ordinance NO. 14, Series 1983 has consented to annexation by the City of Watterson Park;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF WATTERSON PARK:**

SECTION 1. That pursuant to the consent of the owners of the real property and the provisions of Chapter 81A of the Kentucky Revised Statutes, the following described territory be and hereby is annexed to the City of Watterson Park, Jefferson County, Kentucky:

BEGINNING at a point in the present corporate limit line of the City of Watterson Park as established by Judgment of the Jefferson County Circuit Court (Case No. 81-CI-00864), said point being at the intersection of the west right-of-way line of Jennings Lane with the north right-of-way line of the Southern Railroad; thence eastwardly with said corporate limit line and with said line of the Southern Railroad 4,343 feet more or less to its intersection with the original Southwest right-of-way line of Newburg Road; thence in a southeasterly direction with said

right-of-way line of Newburg Road 78 feet more or less to its intersection with the south right-of-way line of the Southern Railroad; thence westerly with said south right-of-way line of the Southern Railroad, 4,343 feet more or less to its intersection with the west right-of-way line of Jennings Lane, then with said right-of-way line of Jennings Lane in a northerly direction 78 feet more or less to the point of beginning, containing 7.8 acres more or less.

SECTION 2. The City Clerk is hereby authorized and directed to publish and advertise this ordinance as required by Chapter 424 of the Kentucky Revised Statutes upon its passage and approval.

SECTION 3. This Ordinance shall take effect immediately upon its passage, approval and publication as required by Chapter 424 of the Kentucky Revised Statutes.
