JUDGMENT

At a Court held October 2, 1951.

This cause coming on to be heard, and it appearing to the Court that due notice of the filing of a petition herein and the object thereof has been published in two issues of the Louisville Times on the 10th and 11th days of September, 1951, said newspaper being published in and of general circulation in Jefferson County, Kentucky, and it further appearing to the Court from the pleadings herein that the requirements of K. R. S. 81.050 and K. R. S. 81.060, pertaining to the incorporation of a sixth class City have been complied with and no defense having been interposed, IT IS NOW ORDERED AND ADJUDGED:

1. That a municipality by the name of "West Buechel" be and it is hereby established as a municipal corporation of the sixth class within the following described boundary:

BEGINNING at a point in the northern line of the right of way of the Southern Railway and the eastern line of the right of way of Old Shepherdsville Road; thence in an easterly direction to a point where the north line of said right of way of said Southern Railway intersects the easterly line of Lincoln Terrace Subdivision, which subdivision is shown in the Office of the Clerk of Jefferson County Court, Kentucky, in Plot Book 4, at pages 30 and 31; thence

line of Glengyle Avenue to a point in the south line of Shelton Avenue where it intersects with the south line of Glengyle Avenue; thence in a northwesterly direction with the south line of Shelton Avenue to a point where it intersects with the western line of Manor Parkway; thence in a southwesterly direction with the western line of Manor Parkway 700 feet; thence in a southeasterly direction to a point in the eastern boundary of Old Shepherdsville Road where it intersects the southern boundary of Bashford Avenue; thence in a southerly direction with the eastern line of Old Shepherdsville Road across St. Francis, Marvin and Ethel Avenues to the point of beginning, being an oblong, rectangular square, no line or outside dimension of which is more than 2,640 feet or one-half mile and the total dimensions of which are less than one-half mile in each direction, with limited variances as permitted in K.R.S. Chapter 81.

2. IT IS FURTHER ORDERED AND ADJUDGED that the following named persons be, and they are hereby appointed as temporary officers of said municipality to the office set opposite their respective names, each of whom shall hold their respective offices until their successors have been duly qualified by law:
