On motion of plaintiffs, by counsel, and it appearing that a petition has been filed pursuant to K.R.S. 81.050 to establish the City of Westwood, and that notice of said filing having been duly advertised pursuant to said statute and by Order of this Court, and the Court being sufficiently advised,

IT IS THEREFORE ORDERED AND ADJUDGED that the following described area be, and it is hereby Incorporated into a Sixth Class City known as City of Westwood:

BEGINNING at a point, said point being the Northeast corner of Lot Number 25 as shown on plat of Westwood Subdivision, Section 2-A, plat of which is recorded in Plat and Subdivision Book 22, Page 56, in the office of the County Clerk of Jefferson County, Kentucky, said point also being in the Southwest line of the City of Rolling Hills as set out in the petition filed in Action Number 96686, in Jefferson Circuit Court, Chancery Branch, Fourth Division; thence with the East line of Westwood Subdivision, Section 2-A aforementioned, South 22 degrees 41 minutes 18 seconds East 1570.89 feet to a point, said point being the Southeast corner of Lot Number 73, as shown on plat of Westwood Subdivision, plat of which is recorded in Plat and Subdivision Book 22, Page 57, in the office of the County Clerk aforesaid; thence South 67 degrees 18 minutes 42 seconds West 1570.89 feet to a point; thence North 22 degrees 41 minutes 18 seconds West 1570.89 feet to a point; thence North 67 degrees 18 minutes 42 seconds East 1570.89 feet to the point of beginning.

It is further Ordered that the following named persons are hereby appointed members of the Board of Trustees of the City of Westwood:

All of the Trustees and Officers above appointed, shall hold their respective offices until the next election at which time officers for cities and towns may be elected.

Qualifications of said officers shall be as provided by law and they shall take office upon their taking their respective oaths of office and executing their respective bonds, where required, and fulfilling any and all other obligations that may be provided by law; record of same shall be entered upon the records of the said City and copies of said record may be certified by the City Clerk as needed.

The Clerk of the Court, not later than ten (10) days after Judgment is entered herein, shall certify a copy of this Judgment to the Secretary of State of Kentucky, Frankfort, Kentucky, whose duty it shall be to properly enter and file this Judgment in the Secretary

of State's office.
