ORDINANCE NO. 1993- 354

AN ORDINANCE ANNEXING TO THE INCORPORATED TERRITORY OF THE  
CITY OF WILLIAMSTOWN, KENTUCKY, CERTAIN UNINCORPORATED  
TERRITORY CONTIGUOUS TO THE PRESENT CORPORATE LIMITS OF THE  
CITY OF WILLIAMSTOWN, KENTUCKY

WHEREAS, the City Council of the City of Williamstown, Kentucky has passed Ordinance No. 1993- 352, stating the intention of the City of Williamstown, Kentucky to annex certain unincorporated territory contiguous to the present corporate limits of the City of Williamstown, Kentucky on second reading on November 1, 1993 and has published the same Ordinance as required by law on November 4, 1993 in The Grant County News, and;

WHEREAS, each of the owners of record of such territory have consented in writing to the annexation of their property in accordance with KRS 81A.412,

NOW, THEREFORE, be it ordained by the City of Williamstown, Kentucky as follows:

SECTION ONE

The unincorporated territory platted in Exhibit A attached hereto and incorporated herein by reference as if fully set out and described as Lots 1 through 4, inclusive, of the James F. Wilson, Jr. Subdivision, Section One, as shown on the plat recorded in Plat Book 5, Page 17 of the Grant County Clerk's Records at Williamstown, Kentucky, being adjacent and contiguous to the present corporate limits of the City of Williamstown, Kentucky, is annexed and made a part of the corporate territory of the City of Williamstown, Kentucky, for all purposes.

SECTION TWO

All ordinances, resolutions, or parts thereof in conflict herewith, are to the extent of such conflict, hereby repealed.

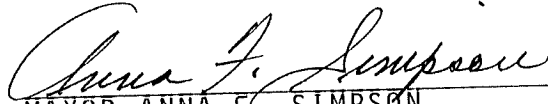
SECTION THREE

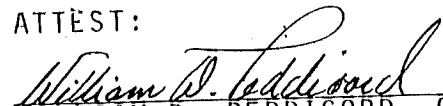

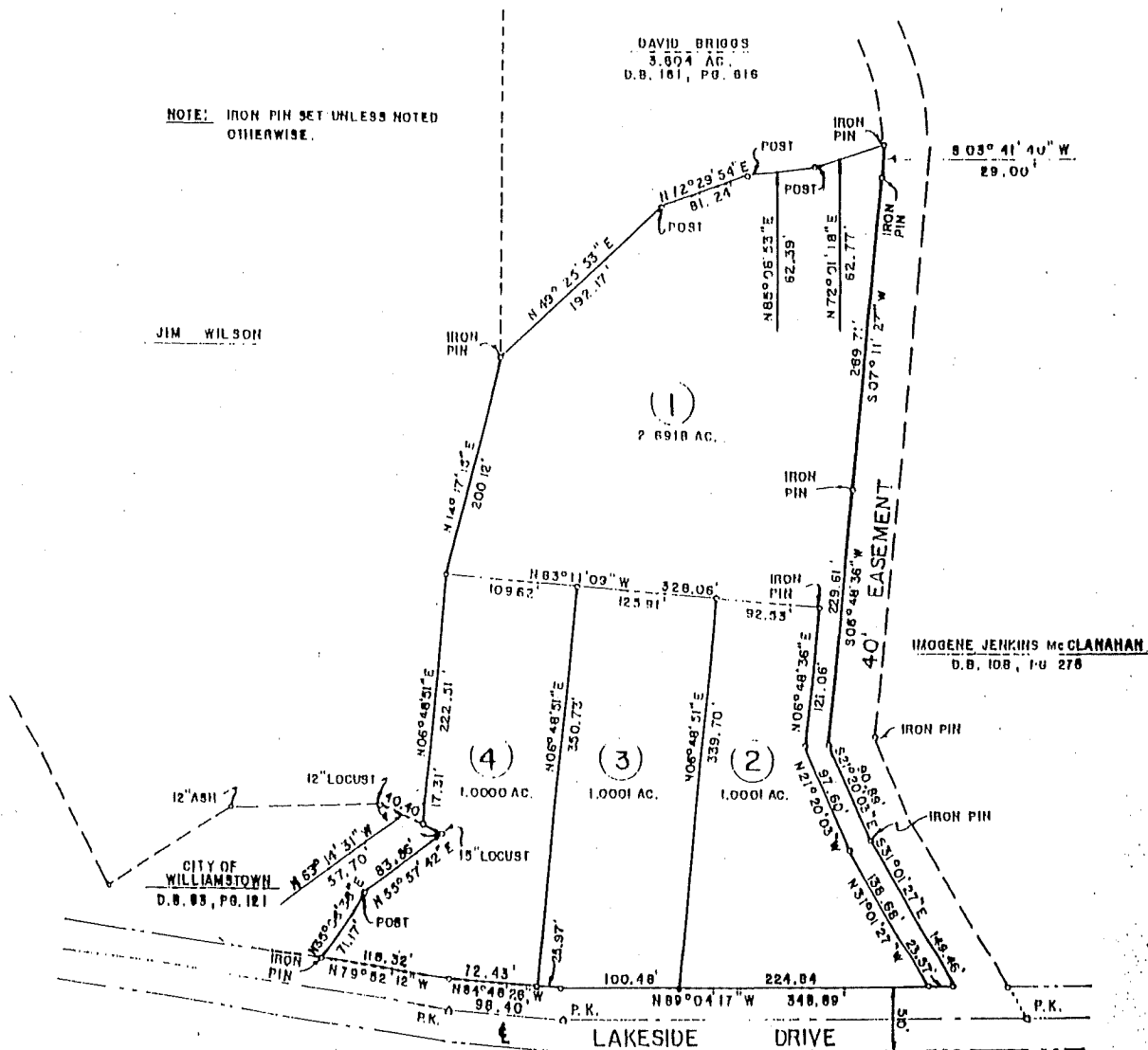
