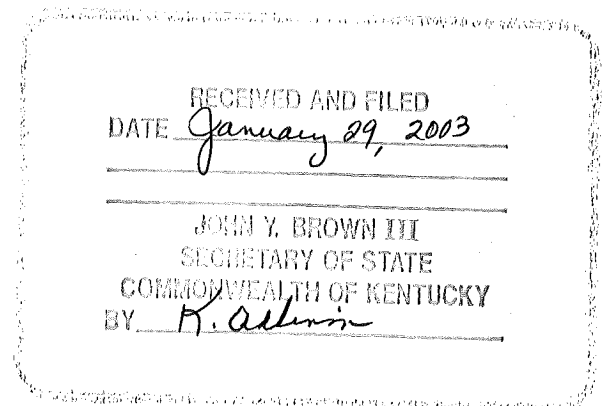

AN ORDINANCE RELATING TO ANNEXATION OF LAND  
OR TERRITORY TO THE CITY OF WILLISBURG, KY

WHEREAS, the City of Willisburg intends to annex  
a 95.52 acre tract of land located on the north and south  
side of Highway #433, southeast of Willisburg  
and

WHEREAS, the owners of said property desire the  
annexation and have committed to same; and

WHEREAS, it is believed that such annexation will be  
desirable and beneficial to the City of Willisburg and to  
the citizens in the area to be annexed.

NOW, THEREFORE, be it ordained by the City Council of  
the City of Willisburg, Kentucky, as follows:

SECTION I - That pursuant to KRS 81A.420 and all other  
applicable law, the land or territory herein after described,  
shall be, and hereby is, a part of the City of Willisburg,  
Kentucky, said property this day annexed being on the north and  
south side of Kentucky Highway #433, southeast of Willisburg in  
Washington County, Kentucky, and more particularly described  
as follows:

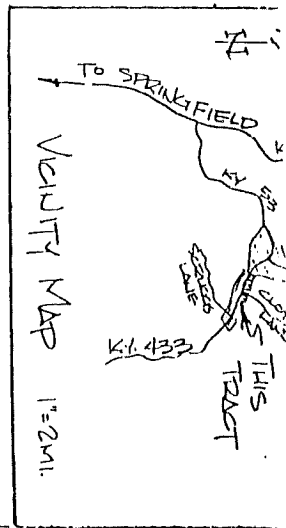
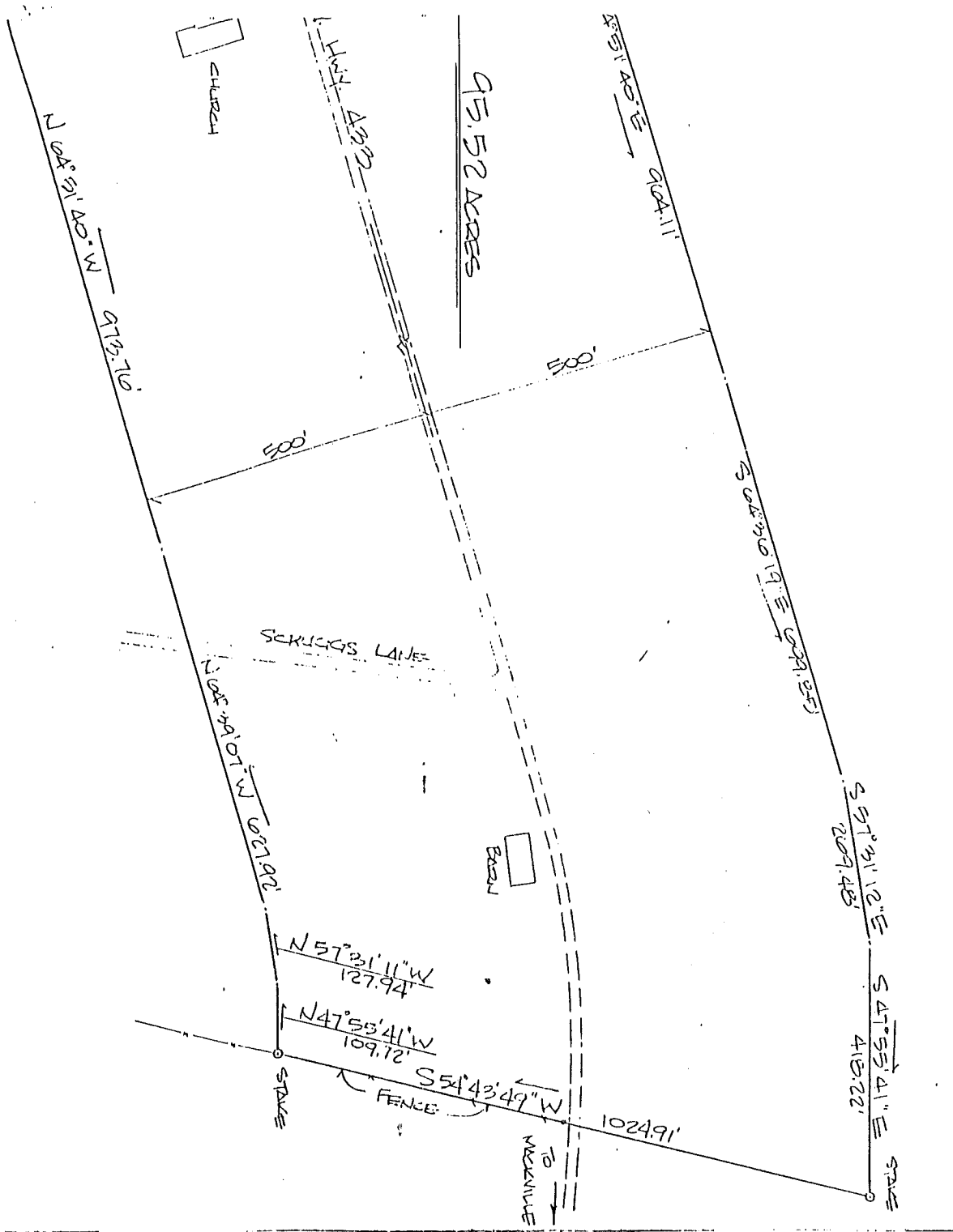
A CERTAIN TRACT OF LAND located on

BEGINNING at a stake near a house, being the southeast corner of the city limits of Willisburg; thence with the east line of the City of Willisburg N 04-09-13 E 594.91 ft. to a point in the center of the old silo; thence N 12-09-13 E 187.02 ft. to a stake in the east line of the City of Willisburg; thence running 500 ft. from and parallel with Ky. SECTION III - The City Clerk shall cause this  
Ordinance to be published in accordance with the appropriate  
Kentucky Revised Statute.
