

ORDINANCE NO: 317-88

AN ORDINANCE ESTABLISHING A DECREE OF ANNEXATION OF THE
HEREINAFTER DESCRIBED PARCEL OF LAND
INTO THE CITY OF WILMORE, KENTUCKY

WHEREAS, on ^{FEB. 15}~~March 17~~, 1988, the City of Wilmore, by and through its City Counsel passed an Ordinance of intent to annex all the property known and described herein as Exhibit "A";
