

ORDINANCE 326-88

AN ORDINANCE ESTABLISHING A DECREE OF ANNEXATION OF THE
HEREINAFTER DESCRIBED PARCEL OF LAND
INTO THE CITY OF WILMORE, KENTUCKY

WHEREAS, on August 15, 1988; the City of Wilmore, by and through its City Council passed an Ordinance of Intent to Annex all the property known and described herein as Exhibit "A";

WHEREAS, no protest or petition has been filed with the Mayor of the City of Wilmore within the sixty (60) days after the date of the enactment of the Ordinance of Intent;

WHEREAS, THE City of Wilmore is still desirous of extending its corporate city limits by annexing the property know and described herein as Exhibit "A."

NOW THEREFORE BE AND IT IS HEREBY ORDAINED, that the property described herein as Exhibit "A" is annexed into the City limits of the City of Wilmore, Jessamine County, Kentucky.

This DEED OF CONVEYANCE made and entered into this day of June, 1969, by and between Jeannette Neal, resident of Mercer County, Kentucky; David G. May, Jr., Executor of the Estate of George P. Cox, resident of Jessamine County, Kentucky, Grantors, and Thelma C. May, Grantee, of Mercer County, Kentucky,

WITNESSETH: That Grantors for and in consideration of nineteen thousand five hundred dollars (\$19,500.00), cash in hand paid to Jeannette Neal, Grantor herein, the Grantors have this day bargained and sold and do by these presents alien and convey all of Grantors' right, title and interest in and to the real estate with improvements thereon as hereinafter described, to-wit:

Located in Jessamine County, Kentucky, at the southern edge of the town of Wilmore, on the Glass Mill Road and the Camp Grounds road.

Beginning at a post in the edge of a rock curb on the edge of the Glass Mill road at a corner to Knott Grimes. Thence leaving road with line of Grimes N 38 E 4.82 chains to post, corner to Grimes and Penrod. Thence with line of Penrod N 71 E 7.21 chains to post, corner to Penrod and McMillin. Thence with line of McMillin S 2 1/2 W 0.41 chain to post, S 87 E 19.76 chains to post, S 2 W 1.50 chains to post, S 87 E 16.24 chains to post, corner to McMillin and Heard. Thence with line of Heard S 1 W 19.72 chains to post on the edge of the Camp Grounds road at a turn in the road. Thence with the edge of the Camp Grounds road N 87 1/2 W 16.38 chains to post on the edge of the road at a corner to the Camp Grounds. Thence leaving road with line of the Camp Grounds N 1/2 E 13.65 chains to post, N 88 W 13.46 chains to post, N 4 W 1.05 chains to post, S 76 W 10.92 chains to post at edge of the curb on the edge of the Glass Mill Road. Thence with the edge of the curb of the road N 46 1/2 W 4.96 chains, N 62 W 3.55 chains to the point of beginning, containing 54.418 acres, according to a plat and survey thereof made by James Godley, Registered Land Surveyor No 1118, under date of May 20th, 1969, copy of which plat is filed herewith, made a part hereof.
