

AN ORDINANCE ESTABLISHING A DECREE OF ANNEXATION OF THE  
HEREINAFTER DESCRIBED PARCEL OF LAND  
INTO THE CITY OF WILMORE, KENTUCKY


WHEREAS, on ~~March 19, 1988~~ <sup>DEC. 1, 1987</sup>, the City of Wilmore, by and through its City Counsel passed an Ordinance of intent to annex all the property known and described herein as Exhibit "A";


WHEREAS, no protest or petition has been filed with the Mayor of the City of Wilmore within the sixty (60) days after the date of the enactment of the Ordinance of intent;

WHEREAS, the City of Wilmore is still desirous of extending its corporate city limits by annexing the property known and described herein as Exhibit "A";

NOW THEREFORE BE AND IT IS HEREBY ORDAINED, that the property described herein as Exhibit "A" is annexed into the City limits of the City of Wilmore, Jessamine County, Kentucky.

ORDINANCE 309-87

AN ORDINANCE OF INTENT OF THE CITY OF WILMORE, KENTUCKY TO ANNEX PROPERTY

Be it ordained that inasmuch as KRS 81A.420 provided for the annexation of unincorporated territory by Cities, and the City of Wilmore, Kentucky by and through its City Council deem it desirable to annex all of the property known and described herein do hereby adopt this Ordinance and intention to annex same.

DESCRIPTION OF PROPERTY

All that tract or parcel of land being approximately 0.90 miles south of Wilmore, Kentucky, West of Ky. Highway 1268 in Jessamine County and being more particularly bounded and described as follows:

Beginning at the southwest corner at the City of Wilmore property as recorded in Deed Book 50, page 54, said point being approximately S70-49-01W 182.60 feet from the centerline of Ky. Highway 1268 and said point being a corner to David and Miriam Rhorer property; thence with a new division through the David and Miriam Rhorer property for seven calls: S70-49-01W 151.61 feet; N66-07-47W 470.13 feet; N38-03-46W 85.47 feet; N25-55-35E 20.85 feet; N11-46-22E 17.85 feet; N08-33-56E 100.55 feet; and S77-19-52E 515.93 feet to an iron pin set on the north side of a gate post and being in the west line of the City of Wilmore property as recorded in Deed Book 50, Page 54; thence with the City of Wilmore property for three calls: S04-36-00W 97.19 feet; S18-51-18E 80.07 feet; and S53-04-28E 95.84 feet to the beginning and containing 2.979 acres.

If no Petition in opposition to said annexation has filed with the Mayor within 60 days after the date of publication of this Ordinance, signed by 50% of the resident voters or owners of real estate within the limits of the territory proposed to be annexed, then the Final Ordinance will be presented to the legislative body whereupon the enactment of annexation shall be final.
