

ORDINANCE NO. 438-96

**AN ORDINANCE FOR ANNEXATION OF PROPERTY INTO THE CITY OF WILMORE, KENTUCKY**

BE IT ORDAINED that inasmuch as KRS 81A provides for the annexation of unincorporated territory by cities, and the City of Wilmore, Kentucky, by and through its City Council, deems it desirable to annex all the property known and designated as Exhibit "A", attached hereto and incorporated by reference.

BE IT THEREFORE KNOWN that the City of Wilmore, Kentucky, by and through its City Council does hereby adopt this Ordinance of Annexation of said property attached hereto as Exhibit A. Since this property is owned entirely by the City of Wilmore, Kentucky which owner has given its consent to annexation in writing and pursuant to KRS 81A.412 the City does hereby adopt this Ordinance of Annexation whereupon enactment of annexation shall be filed.

This Ordinance given its first reading at the regular scheduled meeting of the Wilmore City Council on the 19th day of February, 1996 with a vote of 5 yes and 0 no.

This Ordinance given its second reading on the 4th day of March, 1996 with a vote of 6 yes and 0 no.

## EXHIBIT A

All that tract or parcel of land situated in Jessamine County, Kentucky, on the Lexington Harrodsburg, and Perryville Pike, and bounded as follows:

**BEGINNING** at a stake in the middle of said Pike, marked by a stone on the east side of the Pike, corner to John T. Veatch and J. A. Fisher; thence S 55 W 77.3 poles to a stake in the northwest margin of the pike corner to J. A. Fisher; thence S 42 1/2 W 73.9 poles to a stake in the middle of said pike, marked by a stone on the east side of the pike corner to John B. Jewell; thence leaving the pike S 49 E 161.2 poles to stone corner to John B. Jewell and John Asbury; thence N 21 3/4 E 63.8 poles to end of stone wall corner to John Asbury; thence S 86 3/4 E 80.2 poles to stone corner to John Asbury; thence N 9 E 25 poles to stone corner to Asbury, Thompson and Veatch; thence N 42 1/2 W 710.74 poles to the beginning, containing 143 1/2 Acres.
