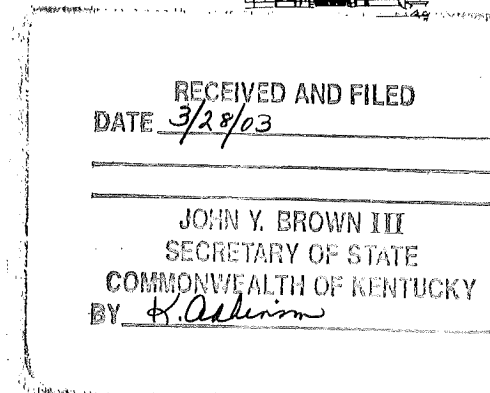

**AN ORDINANCE REPEALING ORDINANCE 21-2002
TITLED "AN ORDINANCE ANNEXING TO THE CITY OF
WINCHESTER, KENTUCKY, CERTAIN LAND IN CLARK
COUNTY, KENTUCKY, LYING GENERALLY SOUTH OF
AND ADJACENT TO THE EXISTING CITY LIMITS ON
THE SOUTH SIDE OF ROAD AND KNOWN AS
2500 COLBY ROAD**

WHEREAS, the Board of Commissioners of the City of Winchester, Kentucky, deems it advisable that, owing to a procedural error, it is in the best interest of the City to repeal Ordinance 21-2002 titled "An Ordinance Annexing to the City of Winchester, Kentucky, Certain Land in Clark County, Kentucky, Lying Generally South of and Adjacent to the Existing City Limits on the South Side of Colby Road and Known as 2500 Colby Road."

NOW, THEREFORE, BE IT ORDAINED by the City of Winchester, Kentucky as follows:

SECTION I. That Ordinance 21-2002, titled "An Ordinance Annexing to the City of Winchester, Kentucky, Certain Land in Clark County, Kentucky, Lying Generally South of and Adjacent to the Existing City Limits on the South Side of Colby Road and Known as 2500 Colby Road" is hereby repealed.

SECTION II. This Ordinance shall become effective upon publication as required by law.

Introduced and given first reading at a meeting of the Board of Commissioners of the City of Winchester, Kentucky held on the 4th day of February, 2003, and finally adopted after second reading at a meeting of said Board held on the 8th day of February, 2003.
