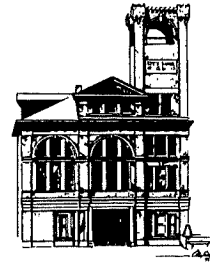




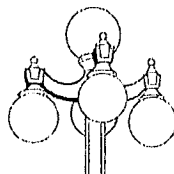

ORDINANCE NO. 10-90

AN ORDINANCE ANNEXING TO THE CITY OF WINCHESTER, KENTUCKY, CERTAIN LAND IN CLARK COUNTY, KENTUCKY, LYING NORTHWEST OF THE EXISTING CITY LIMITS, BEING PROPERTY OWNED BY THE WINCHESTER-CLARK COUNTY INDUSTRIAL DEVELOPMENT AUTHORITY, AND ADJACENT TO THE WINCHESTER INDUSTRIAL PARK

WHEREAS, the Board of Commissioners of the City of Winchester, Kentucky, adopted Ordinance No. 9-90 on April 24, 1990, proposing to annex certain unincorporated territory located in Clark County, Kentucky, and

WHEREAS, the owner of the property being annexed has requested that it be annexed and has consented to said annexation by letter to the Board of Commissioners dated April 10, 1990, and

WHEREAS, a Summary of said Ordinance was duly published according to the requirements of KRS 83A.060(9);

NOW, THEREFORE, BE IT ORDAINED by the City of Winchester, Kentucky, as follows:

SECTION I. That the following described unincorporated territory, located in Clark County, Kentucky, be and it is hereby annexed to the City of Winchester, Kentucky:

Beginning at an iron pin, corner to M.W. Miller, Jr., and Unit C of the Winchester Industrial Park, said point located N 62°01' West 2689.57 feet from a corner in the existing right-of-way of Old Paris Pike common to M.W. Miller, Jr., and Unit A of the Winchester Industrial Park; thence leaving Miller and with said Unit C, South 60°27' West 670.00 feet to an iron pin, corner to Unit C and Miller; thence leaving Unit C and with Miller, North 10°39' East 432.44 feet to an iron pin; thence South 79°21' East 511.76 feet to the beginning; said tract contains 2.54 acres, more or less, and has been platted as Tract 4 on plat of M.W. Miller, Jr., which is of record at Slide 165-B in the Clark County Clerk's office.

SECTION II. The City Clerk is hereby authorized and directed to publish a summary of this ordinance according to the requirements of KRS 83A.060(9).


SECTION III. This ordinance shall become effective upon publication as required by law.
