On motion of Plaintiffs, by counsel, and it appearing that a petition has been filed pursuant to K.R.S. 81.050 to establish the City of Worthington Hills, and that notice of said filing having been duly advertised pursuant to statute and by Order of this Court, and the Court being sufficiently advised,

IT IS THEREFORE ORDERED AND ADJUDGED that the following described area be, and it is hereby Incorporated into a Sixth Class City known as City of Worthington Hills:

BEGINNING in the Northeast line of Lot #534 of FINCASTLE SUBDIVISION, Section #8, as shown on the plat of same which is recorded in Plat and Subdivision Book 30, Page 30, in the Office of the County Court Clerk of Jefferson County, Kentucky, at a point on the Easterly boundary of said subdivision running thence South 30 degrees 38 minutes 11 seconds East 2,450 feet to a point; thence running South 69 degrees 21 minutes 49 seconds West 2,450 feet to a point; thence running North 30 degrees 38 minutes 11 seconds West 2,450 feet to a point; thence running North 69 degrees 21 minutes 49 seconds East 2,450 feet to the point of beginning.

Said boundary consists of approximately 135 acres.

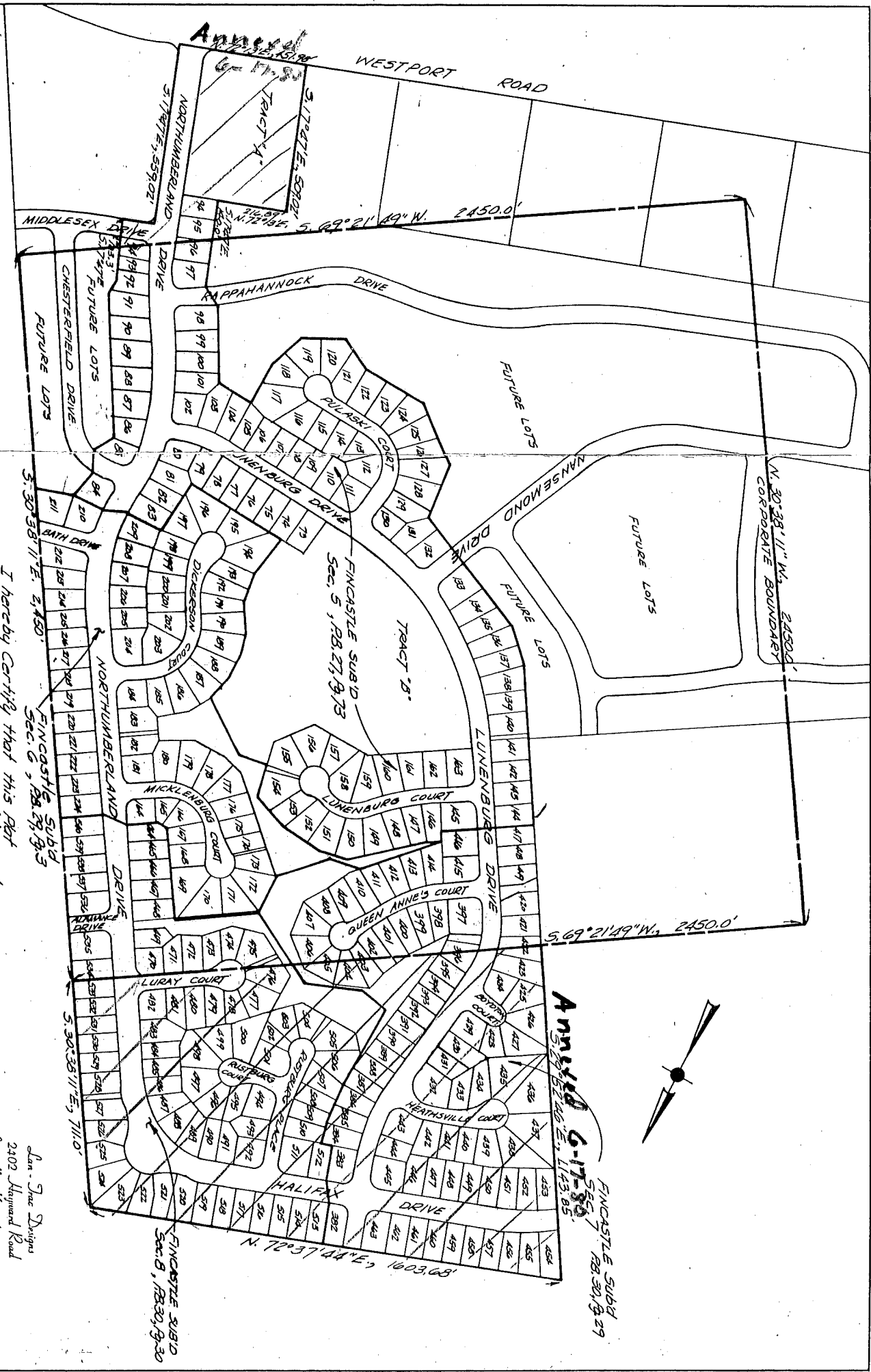

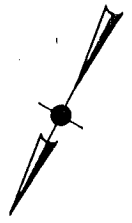

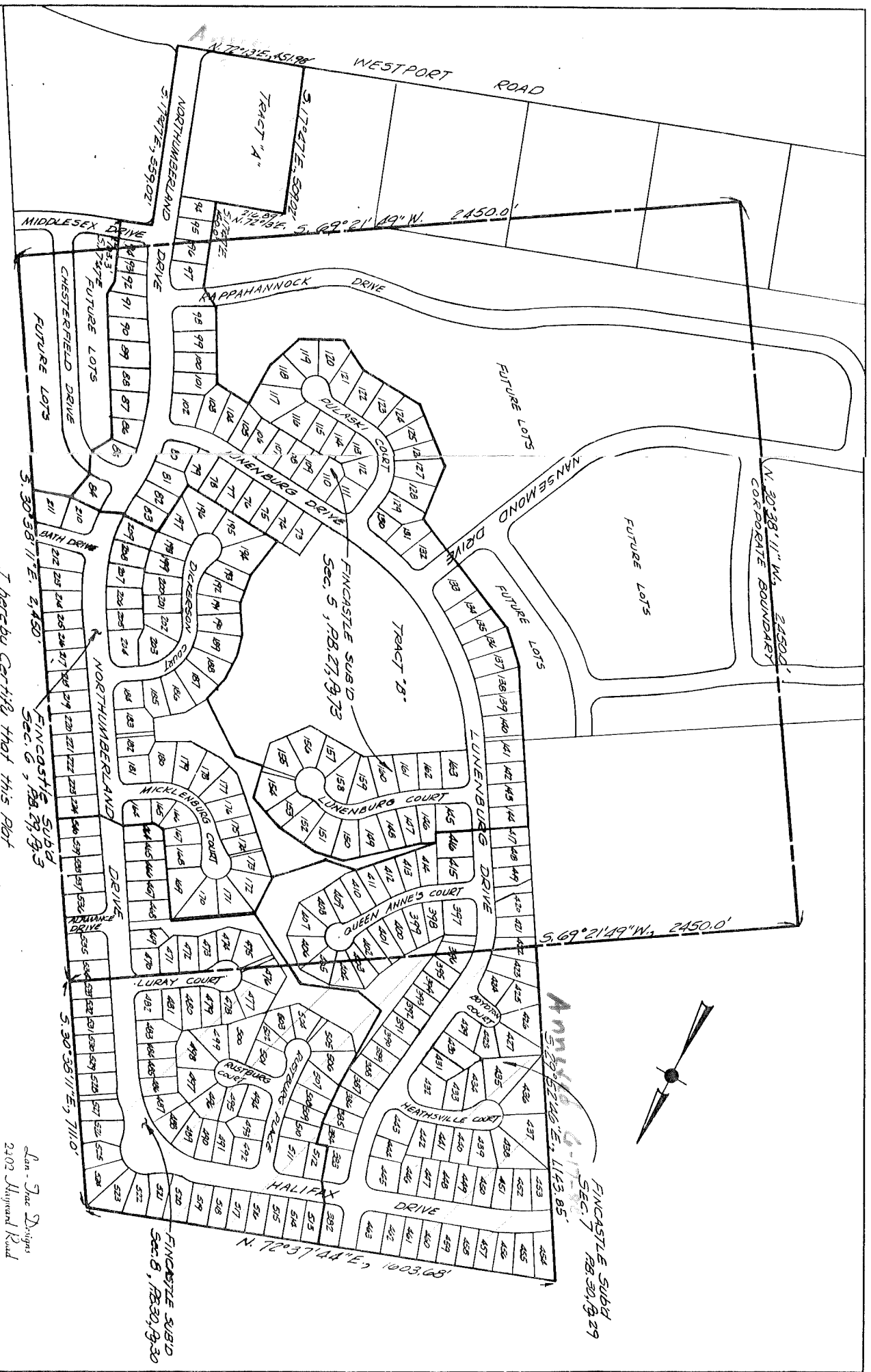
